COVID-19 Municipality Update

April 21, 28 and May 5 2021

CMOH Order 20-2021

Starting May 5, additional restrictions come into effect for regions with at least 50 cases per 100,000 people, and at least 30 active cases.

These restrictions will be in place for at least 3 weeks and will be extended if necessary. Provincewide restrictions remain in effect for all other communities.

With vaccine rollout now including more age groups, will there be new guidelines in general for vaccinated individuals participating in youth sport?	Discussions are on-going and if any changes or updates are made they will be communicated publicly. As of today, individuals who have been given one dose are expected to follow all public health guidelines. Until most Albertans are protected, fully vaccinated people must continue following all public health measures: no indoor social gatherings, keep 2 metres apart from others, wear a mask in public, wash your hands, and stay home when sick.
	Once both doses take effect, you are less likely to become severely sick with COVID-19. But we don't yet know if the vaccine prevents vaccinated people from spreading the virus. We must continue reviewing emerging evidence on asymptomatic and variant transmission before we can safely alter public health guidelines. We will let Albertans know when rules for fully vaccinated people can be

Are any options being considered for mobile vaccination clinics for remote congregate living situations? Especially where workers are unable to travel to walk-in clinics or other options.	Sector discussions are occurring to determine how immunizations can be delivered in remote work settings. Immunization partners such as AHS and pharmacies are working to provide advice on the best options. Due to storage and handling requirements, care must be taken when distributing vaccines across the province, which can make it very difficult to run short term mobile clinics in multiple settings. Wherever possible, employers are encouraged to support their staff in accessing established AHS, pharmacy or physician clinics. This may include providing adequate time for staff to leave worksites to access vaccines.
If regular shipments are secured, will the 16-week window for the second dose be reduced?	Yes, if we have adequate supply once all Albertans have had the opportunity to receive their first dose, we will reduce the window for receiving the second dose.
Can you provide an update to pharmacy and doctor's offices vaccine distribution plans?	To find out what pharmacies are providing vaccinations, and which types of vaccine they are able to offer, please visit the Alberta Blue Cross website: https://www.ab.bluecross.ca/news/covid-19-updates.php . A pilot program is underway in 10 physicians' clinics across the province to test distribution and supply logistics. When the program expands in May, further information will be shared with the public.
Can you take Moderna first shot and Pfizer second shot	The preferred approach will be to provide you with the same vaccine in your first shot and second shot. However, if necessary due to interruptions in supply or other circumstances, the same type of vaccine can be substituted or interchanged. As both Pfizer and Moderna are mRNA vaccines, an interchange can occur.
As our most at-risk populations (to severe outcomes) become the heaviest vaccinated, does it not make sense to shift to a risk of exposure prioritization approach? Surely a 45 year old who can work from home is much lower risk than a 30 year old teacher, transit driver, etc.	We recognize that many people would benefit from being immunized, and we want to offer it to them as soon as possible. There is still limited supply, so we continue to target those who are most at risk of severe outcomes. If additional vaccines are approved and become available, people between the ages of 18 and 64 who are work in specific workplaces or industries may be included in Phase 2.
Why is Alberta (and Canada) offering boosters so much later than other countries around the world? what is the difference in effectiveness between a booster offered within 6 to 8 weeks versus a booster ordered within 16 weeks?	Emerging evidence shows first doses of the vaccine are at least 80% effective at preventing severe illness. Second doses are necessary to ensure you're protected for as long as possible.
	Second doses are being administered up to 4 months later so all Albertans over 18 can be protected with the first dose by the end of June. This change is in line with many other jurisdictions and in line with recommendations from the National Advisory Committee on Immunization (NACI).
	First and second dose appointments are booked separately. Reminders to book second appointments will be issued.

There is no clinical or public health benefit to widespread serological testing or to an individual learning their serology result, because it cannot at this time provide assurance that a person will not become sick with COVID-19 again in the future. Alberta Health has invested in four voluntary public health studies, which will serologically test specific groups of Albertans for the virus. Two studies are using established cohorts and are not open for recruitment. One study is anonymous and random so individuals will not be aware if they have been tested or of their testing results. Only one study, Alberta COVID-19 Child Cohort (AB3C), is recruiting patients. More information on this study can be found here.

Violators may be subject to issued tickets and more serious violations may result in prosecution before the courts.
what is the province doing about enforcement of violators of the Act?	The province will take an education first approach. However, we recognize that in some cases this approach is not effective. As a result, fines will be handed out. A blanket Court Order has also been issued to AHS to apply against any illegal gathering – that is, a gathering that is focused on the promotion of violating public health orders. Organizers of this event can be arrested under this Order. It has now been used for a few Illegal Gatherings that have taken place recently.

Travel	
Will travel be allowed for those who are fully vaccinated?	Travel currently is only recommended for essential purposes. Decisions related to international borders are the jurisdiction of the federal government. With travelling, it is always the responsibility of the traveller to ensure they meet the requirements of the jurisdiction they are travelling to, for example, having a visitor's visa or being immunized. A number of jurisdictions around the world require travelers to provide proof of immunization prior to entry into the country. For instance, countries like Congo, Niger and Rwanda require proof of yellow fever immunization. Some international jurisdictions may implement requirements to show a record of COVID-19 immunization prior to entry. Therefore, it is highly recommended that travelers fully understand any entry requirements for any jurisdictions they plan to travel.

Council Meetings

Have there been any changes to council meeting procedures with the return to Step 1?

NO. There have been no changes to council meeting procedures. The Public Meeting Procedures (COVID-19 Suppression) Regulation remains in effect for councils to conduct council meetings by entirely electronic means to help control the spread of COVID-19. All attendees of meetings held in person must wear masks and socially distance, as required by public health orders.

Municipal Election

Does the Government of Alberta have plans to allow for expanded use of special ballots for the 2021 general election?

NO. Municipal Affairs will continue to monitor developments relating to the pandemic, but based on progress to date in the vaccine rollout, it is anticipated votes will be able to take place safely according to relatively normal processes. No changes to special ballot provisions are planned at this time.

Recreational Facilities

Can splash parks, outdoor pools, and other outdoor facilities operate as part of the Step 1 restrictions?

YES. Outdoor fitness and recreation facilities may be used, as long as they align with public health guidelines. Physical distancing of two metres between households or individuals is required, and group activities can have a maximum of 10 attendees. If activities cannot be made to align with public health guidelines, the activity is not permitted.

Can municipal golf courses be open?

YES. Golf courses and driving ranges are allowed to open. As with other activities, physical distancing is required, and group activities can have a maximum of 10 people.

Can indoor recreational facilities be open?

YES. Indoor recreational facilities are permitted to be open; however, indoor recreational spaces may only be used for individual or household one-on-one fitness training. Indoor group fitness for adults is not permitted (both low and high intensity). Youth lessons, practices, and physical conditioning activities are allowed for indoor and minor sports/activities. Youth school athletics are linked to school board decisions so for all places shifting to online schooling, indoor youth sports activities will be paused. Games are not allowed.

Can campgrounds with toilets and showers be open?

YES. Shared amenities and high-touch surfaces should undergo regular cleaning and disinfection procedures with increased frequencies.

Can community halls be open?

YES. Community halls may be open for any activities permitted under Step 1, such as wedding ceremonies (up to 10 people) and funeral services (up to 20 people). Receptions and trade shows are not permitted. Group meetings may be held so long as masks are worn, individuals or households are spaced at least two metres apart, hand hygiene facilities are available, and movement through the facility can be properly facilitated.

Can municipalities choose to keep municipal properties closed even if they can be open under Step 1?

YES. The decision to open facilities remains a local council decision. Municipalities and the public must continue to put safety first.

Are adult team sports, such as softball, allowed to proceed?

NO. Adult team sports are not permitted under the current guidelines. Adult team sports may be part of Step 3 of the Path Forward.

General Questions

Are municipalities responsible in any way for use of their community halls or facilities in contravention of the order or parameters of use under the Public Health Order?

YES. Community hall and facility operators, including municipalities, are responsible for any contravention to public health orders that occur within their premises.

Should municipalities be encouraging employees to work from home?

YES. Working from home is mandatory unless the employee's physical presence is required to meet operational needs. While in the office, individuals must practice social distancing and wear masks when in public areas of the office. Municipal staff should be encouraged and supported to have remote work arrangements where feasible.

Municipalities in High Case Areas

Do the newly announced restrictions only apply in areas with high case rates?

YES. Restrictions still apply across the province, but starting May 5, additional restrictions came into effect for regions with at least 50 cases per 100,000 people, and at least 30 active cases. To determine if these restrictions apply to your region, visit alberta.ca/stopthespike.

Are outdoor recreational facilities and fitness facilities permitted to remain open in municipalities with high cases?

YES. However, all outdoor sports and recreational activities are only permitted for members of one household or, if living alone, one person and their two close contacts. This includes all group physical activities and team sports, as well as any group or one-on-one lessons, training, practice, or games. For additional restrictions on events and participants, visit alberta.ca/COVID19.

Can campgrounds with toilets and showers be open?

YES. Shared amenities and high-touch surfaces should undergo regular cleaning and disinfection procedures with increased frequency, and patrons must follow the physical distancing guidelines in place at the time.

Will we be notified if our municipality moves into the criteria that enhanced measures apply?

YES. Should a community have enough cases to be bumped into the areas with enhanced measures, you will be contacted by a representative from Alberta Health Services to notify you of the change.

Are municipalities expected to follow the work from home requirement?

YES. Working from home remains mandatory. Work from home requirements apply to municipal offices, public works facilities, and any other municipal facilities unless the employee's physical presence is required to operate effectively. When at work employees must mask for all indoor settings, except where physical distancing is practiced or adequate barriers are in place.

Are municipalities responsible in any way for use of their community halls or facilities in contravention of the order or parameters of use under the Public Health Order?

YES. Community hall and facility operators, including municipalities, are responsible for any contravention to public health orders that occur within their premises.

Municipalities in Lower Case Areas

If our region has less than 50 cases per 100,000 or less than 30 active cases, are <u>indoor</u> activities permitted?

NO. All indoor fitness facilities must close. Effective May 9, indoor sport, performance and recreation activities are not permitted. No games, competitions, practices, or league play of any kind are allowed.

If our region has less than 50 cases per 100,000 or less than 30 active cases, are <u>outdoor</u> activities permitted?

YES. For outdoor facilities, games, competitions, and team sports are permitted where participants can maintain 2 metre physical distancing at all times.

Outdoor fitness or sports training for individuals and groups to a maximum of 10 people is permitted provided 2 metre physical distancing is maintained at all times.

Outdoor group physical activity is limited to 10 people or fewer. Participants from different households must maintain 2 metre physical distancing at all times.

Individual sports activities such as running, cycling, dirt biking, and golfing (disc and regular) are permitted. Outdoor pools, tennis and pickleball courts, croquet pitches, running tracks and other similar outdoor facilities may be open, but can only be used by household groups, or individuals who live alone and their cohorts and must ensure 2 metre physical distancing is maintained at all times.

To all Chief Administrative Officers:

I am writing to share with you a recent ministerial order (MSD:022/21) signed by the Honourable Ric McIver, Minister of Municipal Affairs. A copy of the ministerial order and applicable regulation are attached for your information.

This ministerial order is enacted under the authority of Section 694(i)(h.2) of the *Municipal Government Act* (*MGA*), and establishes the Subdivision and Development Appeal Regulation, which clarifies which appeal body will hear subdivision and development permit appeals for certain matters. The regulation:

- clarifies that appeals that have limited provincial interest will continue to be heard by local subdivision and development appeal boards;
- further clarifies that approvals of the Minister of Environment and Parks include approvals under Acts for which the Minister is responsible; and
- exempts Natural Resources Conservation Board-designated lands in the Town of Canmore from the application
 of additional MGA sections, making sure that the intent of the board's 1992 decision, allowing development in
 the Three Sisters Resort area, is maintained.

This new regulation supports the goal of red tape reduction and encouraging the sustainable development of communities in Alberta.

SUBDIVISION AND DEVELOPMENT APPEAL REGULATION

Definitions

- 1 In this Regulation,
 - (a) "Act" means the Municipal Government Act;
 - (b) "designated land" means designated land as defined in the Canmore Undermining Review Regulation (AR 34/2020).

Appeals removed from list

- 2(1) The following are removed from the list of circumstances where a notice of appeal of a decision of a development authority may be filed with the Land and Property Rights Tribunal:
 - (a) an appeal where the land that is the subject of the application is within the Green Area as classified by the Minister responsible for the *Public Lands Act*, as referred to in section 685(2.1)(a)(i)(A) of the Act;
 - (b) an appeal where the land that is the subject of the application contains, is adjacent to or is within the prescribed distance of a highway, a body of water, a sewage treatment or waste management facility or a historical site, as referred to in section 685(2.1)(a)(i)(B) of the Act.
- (2) Subject to subsections (3) and (4), the appeals referred to in subsection (1) may be commenced by filing a notice of appeal with the subdivision and development appeal board.
- (3) If the land that is the subject of an appeal referred to in subsection (1) is subject to a licence, permit, approval or other



authorization referred to in section 685(2.1)(a)(i)(C) or (D) of the Act, then, despite subsection (1), the appeal may be commenced by filing a notice of appeal with the Land and Property Rights Tribunal.

(4) Subsection (1) does not apply to an appeal if the notice of appeal was filed with the Land and Property Rights Tribunal before the coming into force of this section.

Appeals related to designated land

3 The circumstances listed in sections 678(2)(a)(i) and 685(2.1)(a)(i) of the Act where a notice of appeal may be filed with the Land and Property Rights Tribunal do not include appeals where the land that is the subject of the application is designated land.

Additional circumstances where appeal may be filed

- 4(1) In this section, "Minister" means the Minister of Environment and Parks.
- (2) In addition to the circumstances listed in sections 678(2)(a)(i) and 685(2.1)(a)(i) of the Act, a notice of appeal may be filed with the Land and Property Rights Tribunal where the land that is the subject of the application is the subject of a licence, permit, approval or other authorization granted by the Minister or granted under any Act the Minister is responsible for under section 16 of the Government Organization Act.

Transitional

5 During the period beginning on the day this Regulation comes into force and ending on June 1, 2021, all references to the "Land and Property Rights Tribunal" in this Regulation shall be read as references to the "Municipal Government Board".

6 This Regulation expires on June 30, 2023.






Active case rate per 100k (Municipality)

POSITIVITY RATES BY ZONE (%)






CASES AND HOSPITALIZATIONS OVER TIME











Update from the Legislature - Apr 21

April 21, 2021

The legislature continues to sit this week before breaking for a constituency week next week. MLAs are working their way through the government's spring legislative agenda, with fifteen government bills currently before the legislature.

Last week the province announced additional support for small businesses that have been affected by public health restrictions through the Small and Medium Enterprise Relaunch Grant. Eligible enterprises will be able to receive another payment of up to \$10,000 this month. The province also announced that the eligibility age to receive the AstraZeneca vaccine has been lowered to 40, effective April 20. You may book a vaccine here.

AUMA Villages West Update

Hello Villages West Mayors, Councillors, and CAOs,

I hope that everyone is doing well and staying healthy and safe. Like most, I have been keeping very busy doing regular council and AUMA work while supporting my community as we navigate the unusual times that we are in. I would like to update you on some of the work that we are doing to advocate for Alberta's municipalities.

Local Government Fiscal Framework (LGFF)

As you are aware, AUMA has consistently advocated for a predictable, sustainable funding model that is enshrined in legislation. Owing to this, we were disappointed that the GoA reduced MSI funding to municipalities over three years and postponed the implementation of the LGFF. Based on a Request for Decision (RFD) submitted by the Village of Forestburg at our MLC, the AUMA will be advocating for an increase to the base LGFF funding amount, the removal of the 50% growth restriction, as well as to have LGFF implemented in the 2023/2024 fiscal year.

Bill 52 - Recall Act

The province has passed the Recall Act, Bill 52, which includes recall for Municipal Elected Officials. AUMA was not consulted before the bill was tabled in the legislature. To successfully recall a mayor or councillor, a valid petition signed by eligible voters in a number that is equal to at least 40% of the municipalities population must be submitted to the CAO. If the CAO deems the petition valid, the councillor/mayor is automatically removed, without a vote.

While the thresholds for recall are too high for them to be reasonably met in many municipalities, that is not true for small communities, where in some cases fewer than 50 signatures will be needed to remove a councillor from office. The process becomes even more convoluted and confusing for Summer Villages. With so few signatures needed, I feel that this legislation has the potential to cause governance and viability issues for small communities. AUMA is advocating that the recall threshold be set at 60% for small communities. instead of 40%. We also have concerns with the CAOs role in the process. Given that the CAO is the only employee of council, we feel that having them validate a petition that would remove a sitting councillor from office is a conflict of interest. Compounding this is the fact that a CAO, if they lived in the community, could actually initiate and then validate their own petition. We are recommending that any petitions be validated by a neutral third party. We are also concerned about the financial burden that this could place on municipalities.

Future of Municipal Government Project

Work is moving along nicely on our Future of Municipal Government project. In case you are not aware, the project is meant to ensure that municipalities remain in the drivers seat when it comes to any future changes to municipal government. What we do not want to see is top down solutions being imposed on Alberta's Municipalities, as we have seen in other jurisdictions. We have partnered with the University of Calgary's School of Public Policy to complete the project which will explore and assess options for government structures that will enable municipalities to build thriving communities into the future. We have chosen to partner with the School of Public Policy to keep the board from influencing the project and to ensure an unbiased approach. The project includes 2 phases of deliverables;

- 1. The initial deliverables are research papers on various aspects of municipal government and will be led by the School of Public Policy (SPP).
- 2. The results of these papers will inform the ultimate deliverable, which is a principle-based recommendations paper outlining options that will work in the Alberta context. While the School of

Public policy will play a supporting role in the final recommendations paper, AUMA and our members will lead the formulations of the recommendations.

Federal Gas Tax

I am happy that the federal government will be doubling the Gas Tax that Municipalities receive this year. Much like the last time this happened, AUMA wants to make sure that villages like ours also see a true doubling of the grant and has advocated for the increase to include a doubling of the base amount. To my understanding this will be happening.

Household Hazardous Waste (HHW)

With the impending closure of the Swan Hills Facility, changes have been made by Infrastructure Alberta to the HHW funding structure. Unfortunately, the changes will see costs downloaded onto municipalities and waste commissions. AUMA is working on figuring out the extent of changes and how they will impact municipalities. If you are impacted by this change, please reach out to me and we can chat about the impact that it will have for you so that I can get a better understanding on how we might advocate on this.

Economic Resiliency and Recovery Task Force

This task force has completed its' mandate and submitted its' final report which has been accepted by the Board. The report includes some fantastic recommendations that the board will work on implementing, including the formation of a new standing committee focusing on municipalities and economic development. Community Futures Yellowhead East understands the impacts that the COVID-19 pandemic has had on small business within the CFYE region, as well as the demand currently being placed on municipalities to provide financial and in-kind supports to their local Small Medium Enterprises (SMEs) / Non-Profit organizations.

In recognition of these impacts and demands, CFYE has developed a Regional Business Resilience & Diversification Partnership Initiative Fund, that municipalities can apply to partner with CFYE, in providing supports to SMEs / Non-Profit organizations within the CFYE region.

"This past year has been a time of struggle and uncertainty as we continue to face a world-wide pandemic compounded with an uncertain economic outlook caused by the oil and gas industry crisis." Stated CFYE Board Chair Carol Webster. "As businesses struggle to keep their doors open and staff employed, CFYE is being sought more and more for assistance. Stemming from requests from businesses and Chambers of Commerce in the region to assist municipalities in support of their local business community, CFYE developed the partnership fund with municipalities and Chambers of Commerce in mind."

Community Futures Yellowhead East understands the impacts that the COVID-19 pandemic has had on small business within the CFYE region, as well as the demand currently being placed on municipalities, to provide financial and in-kind supports to their local Small Medium Enterprises (SMEs) / Non-Profit organizations.

In recognition of these impacts and demands, CFYE has developed a Regional Business Resilience & Diversification Partnership Initiative Fund, that municipalities can apply to partner with CFYE, in providing supports to SMEs / Non-Profit organizations within the CFYE Region.

Project Partnership Approval Process and Methodology

The purpose of the CFYE Regional Business Resiliency & Diversification Partnership Initiative Fund is to support municipalities in their individual project efforts, that center on developing and implementing local solutions for SMEs / Non-Profits who have remained resilient throughout the COVID-19 pandemic and are looking to maintain or diversify their businesses in an effort to remain sustainable and competitive within the CFYE region.

The Partnership Initiative Fund will support municipal business retention and diversification strategies in our rural communities and assist those SMEs / Non-Profits who have managed to implement strategies or solutions to remain viable throughout the pandemic and are now looking for additional supports to either expand their operations or to implement additional diversification solutions that will allow SMEs / Non-Profits to continue providing the goods and services required to sustain the local economy.

The goal of the Partnership Initiative Fund is to partner with CFYE regional municipalities in developing and implementing innovative strategies and solutions that will assist local SMEs / Non-Profits who have not only faced the challenges of the COVID-19 pandemic, but who have managed to survive this diversity and are now looking to their municipalities for additional supports to help them remain resilient, as well as to assist in the economic diversification efforts of the CFYE Region.

Municipal Partnership Funding Parameters & Criteria:

- Each Municipal Partnership project proposal: Municipalities submitting proposals for the matching grant fund must Include a CFYE staff member as a committee partner in the implementation of projects that will provide supports to local SMEs / Non-Profit organizations.
- Municipal proposals are required to provide matching dollar-for-dollar and in-kind funding supports and could apply for up to \$70,000 to be used toward approved

municipal partnership projects. Matching ratios must meet 75% in cash contributions and the remaining 25% matching may be provided through in-kind supports.

- Proposals will be considered on a first-come-first-served basis and will be accepted while funds remain available from the CFYE project pool of \$70,000.
- The inclusion of other community stakeholders as project partners in the development, implementation and awareness of approved funding partnership projects is not mandatory but may be given higher consideration during the evaluation process.
- Must include a CFYE staff member, as a committee partner, in developing criteria around which SME / Non-Profit organizations may be eligible to apply to the individual Municipal Partnership Project Fund Initiative and utilize the funds being applied for from the partnership project.
- Must include a CFYE staff member, as a committee partner, in developing an application scoring matrix template which SME / Non-Profit organization grant applications will be rated against and include CFYE staff member in the approval process of those applicants.
- Must Include CFYE staff committee partner in developing outcomes, measurables, and reporting criteria of the project.
- Provide CFYE partner with budget accounting and final reporting of the project.

Municipal Project Activity Criteria:

- Must center on providing supports around building resilient and diversified SMEs
 / Non-Profit organizations in the CFYE region.
- Support business retention, diversification or expansion within the CFYE region.
- Assist in mitigating the economic impact of sustaining and transitioning business models.
- Engage and leverage support of other community or service delivery partners in business resiliency and diversification efforts.
- Include, but not limited to, ie: payment options for annual business permit fees, business tax payment options and incentives, reduced permitting fees, funds to cover increased costs to ensure PPE measures meet restrictions, new tools or equipment that allows a business to expand or diversify from their regular revenue streams, other diversification efforts of a business to remain sustainable and competitive, or membership fees to local business support organizations.

Ineligible Project Activity Expenses:

- As a means to replace existing funding and resource supports already or previously provided by the municipality to their local SMEs / Non-Profits.
- Duplication of services currently being provided by other community partners.

Municipal Project Proposals:

- All municipal proposals that meet the above criteria, as developed by the CFYE Board, will be considered and approved on a case-by cases-basis through CFYE Executive Director and staff.
- Approval of all grant proposals are at the discretion of Community Futures Yellowhead East management and may be refused for any reason.
- Additional conditions may be imposed if deemed necessary and appropriate with the granting of funds.

SME / Non Profit Organization Support & Application Requirements:

- As per Terms and Conditions of the Community Futures Program, Small Medium Enterprises (SMEs) are defined as having less than 500 employees and annual sales revenue of less than \$20 million, and produce goods and services for the market economy, regardless of their business structure (e.g. sole proprietorships, social enterprises, cooperatives, etc.)
- Non-profit organizations are associations, clubs, or societies that are not charities and are organized and operated exclusively for social welfare, civic improvement, pleasure, recreation, or any other purpose except profit.
- SMEs / Non Profits must attest they have not received duplicative supports
 through other municipal, federal or provincial government COVID-19 support
 programming such as the Canada Emergency Business Account, Wage / Rent
 Subsidy program, Small Medium Enterprise Relaunch Grant, RRRF loans
 through CFYE.
- The projects must support SMEs / Non-Profit efforts of businesses that have been proven viable and not experiencing any liquidity or other financial difficulties prior to March 1, 2020.
- The SMEs / Non-Profit must be able to demonstrate resiliency and diversification efforts since March 1, 2020.
- SMEs / Non-Profits must have experienced a material adverse effect on business operations after March 1, 2020, as a result of the COVID-19 pandemic
- Be a sole proprietorship, partnership, corporation, social enterprise or non-profit organization within the CFYE business region.
- Be used for the sole purpose of implementing business sustainability practices, and or diversification tactics that provide products and services vital to the economic diversification of the local municipalities within the CFYE region.
- Must be a SME / Non-Profit organization in good standing with the municipality, provincial and federal government agencies.

 New SMEs / Non-Profits established since March 1, 2020 that have experienced unexpected expenses or revenue losses due to COVID-19 not covered through other funding sources may be eligible to apply based on the criteria outlined in the program.

SME / Non-profit Organizations Ineligible Expenditures:

- Costs that are deemed unreasonable and/or not directly related to business resilience or diversification will be ineligible for funding. These include, but may not be limited to:
 - o Cost incurred before project approval will not be eligible
 - Losses on investments, bad debts and associated expenses, other projects and contracts
 - Refinancing of existing debts
 - Provisions for contingencies or commissions paid to consultants to secure funding
 - Lobbying activities
 - o Donations, dues and irrelevant membership fees
 - o Entertainment expenses
 - Duplication of funds received through other programs.

In addition to providing a program that offers a funding pool from which SME's/Non-Profits can apply to, for individual approved resilience and diversification needs, municipalities have an opportunity to provide and promote many additional supports already being offered such as:

Temporarily Reduced or waived annual business fees:

- Business Taxes.
- Business Licensing or permitting
- Options to pay fees on a quarterly or semi annual basis
- No Interest or penalty's on late payments received within a certain time period

We have been given approval to allow Lemonade Day to move forward under phase 1 health restrictions. While this is fantastic news and what we wanted to hear, there will be some very strict protocols in place.

I am providing a preliminary list of requirements that will need to be met by all participants. We will forward a more detailed list along with all additional materials that municipal staff will require for event promotion, as well we will go over all of the rules and details with participants during the training session.

- 1) All lemonade MUST be prepared on site and cannot have any part of the recipe prepared ahead of time.
- 2) OUTDOOR stands only, indoor settings will not be allowed

TO ALL MEMBERS OF THE REGIONAL WASTEWATER COMMITTEE:

The collection and treatment of wastewater in the Lake Isle, Lac Ste. Anne, and Sandy Lake area became the focus of Regional Wastewater Commissions, Town, Villages, Hamlets, Summer Villages, and First Nations, to decrease the nutrient loading and improve the water quality of the lakes. Under the guidance of the Darwell Regional Wastewater Committee, funding was obtained from Alberta Transportation to proceed with the evaluation of the feasibility of the construction of a wastewater transmission system to service the area. The area included the northwestern portion of Parkland County, the south portion of Lac Ste. Anne County, and the west area of Sturgeon County as well as various Towns, Villages, Summer Villages, and First Nation communities in or adjacent to the area.

The Darwell Lagoon Commission, on behalf of the Regional Wastewater Committee, is please to forward to you the "Darwell Regional Wastewater Committee – Regional Wastewater Transmission Line Conceptual Design" report for your review and information. This Conceptual Design Report presents findings with respect to existing infrastructure in the service areas and their corresponding wastewater generation rates, various strategies for future serving, and technical design criteria for the implementation of detailed design. It also presents opinions of probable costs for the various strategies proposed.

The main finding of the Report is that the cost of constructing stand alone facilities. borne primarily by connected communities, is cost prohibitive leading to the implementation of a regional transmission system being necessary to make future wastewater treatment affordable and operationally feasible. It is recognized that the overall wastewater transmission system must be built in phases starting with immediate areas of concern, scheduling the next phases as existing lagoon systems need upgrading, and continually reviewing the ultimate wastewater treatment method (which will not be required for a number of years). However, this Conceptual Design Report provides municipalities in the area with a direction that will meet the future needs of the area. It is anticipated that the members of the Committee will utilize the information in this Report to proceed on Projects that are components of the overall regional wastewater transmission system. The phasing of the preferred wastewater transmission system (at this time) is shown in Table 15.3; Option 1A: Connection to PLGS at of near Stony Plain via the Isle Lake Extension. Good Afternoon:

As you know, in fall 2020 Community and Social Services launched a review of the Family and Community Support Services (FCSS) program. The review began with stakeholder engagement focusing on four themes:

- FCSS Mandate;
- Funding Prioritization;
- Enhanced Collaboration and Coordination; and
- Accountability and oversight.

Through the review process, FCSS stakeholders were invited to provide input to the review through an online survey. One of the messages CSS heard from stakeholders through the survey and other communication was the need for flexibility in responding to emerging and changing social needs during extenuating circumstances such as those faced by Albertans during the pandemic.

The review has concluded and will result in the development of a framework to strengthen the FCSS program. The framework, which will be developed in consultation with stakeholders and implemented later this year, will have a stronger focus on prevention and enhanced accountability measures. Throughout the development of the framework, FCSS programs will continue to have avenues for input related to the administration of FCSS funding.

The review also presented the opportunity to make changes to the FCSS Regulation, which was set to expire next year. Regulation amendments were proposed to allow for the provision of direct assistance in the case of a public health emergency under the *Public Health Act* or extenuating circumstances as determined by the Minister, align FCSS audit requirements for review engagements with ministry requirements, and address the expiry date and other minor housekeeping changes.

The Regulation changes will take effect on July 1, 2021 and are outlined as follows:

- Add the flexibility to provide vulnerable Albertans with direct assistance like food provision, during
 extraordinary times of crisis, such as pandemics or natural disasters. The current regulation does not
 allow intervention supports.
- Align FCSS audit requirements for review engagements with CSS requirements by changing the threshold for a review engagement report from \$100,000 to \$250,000.
- Repeal section 12 as this section refers to a previous section of the Regulation, which was repealed in 1995 and is no longer required in the current Regulation.

- Improve the consistency of the language in the Regulation around the word "services" to clarify that municipal costs of a program relate to "services provided under the program".
- Extend the expiry date to June 30, 2032.

FAMILY AND COMMUNITY SUPPORT SERVICES AMENDMENT REGULATION

1 The Family and Community Support Services Regulation (AR 218/94) is amended by this Regulation.

 - (k) providing training for staff and volunteers for the delivery of services under the program,
- (f) by repealing clause (m) and substituting the following:
 - (m) employment of staff to deliver family and community support services under the program.
- 4 Section 6 is amended by striking out " $$100\ 000$ " and substituting "\$250 000".
- 5 Section 6.1 is amended by striking out "\$100 000" and substituting "\$250 000".
- 6 Section 12 is repealed.
- 7 Section 13 is amended by striking out "June 30, 2022" and substituting "June 30, 2032".
- 8 This Regulation comes into force on July 1, 2021.

Q&A for the Family and Community Support Services (FCSS) Amended Regulation

Q. Why were changes made to the FCSS Regulation?

A. The FCSS Regulation was set to expire on June 30, 2022 and required review to ensure it remains current and relevant. The FCSS Review and stakeholder feedback received through the review process, provided the opportunity to address the upcoming expiry date and propose other changes to provide additional flexibility, consistency and address minor housekeeping changes.

Specifically, the changes addressed were as follows:

- extend the regulation expiry date;
- add a provision to allow for direct assistance under extenuating circumstances (e.g. food security, transportation of seniors to COVID vaccinations during pandemic, food/clothing during floods, fires, etc.);
- change the review engagement reporting requirements from \$100,000 to \$250,000 to align with Ministry standards; and
- other housekeeping amendments recommended by Legal Services to update the regulation and provide consistency.

Q. Will the changes to the Regulation affect my community's funding?

A. The changes to the Regulation will not affect your FCSS funding allocation. The existing funding model allocates funding based on the population of a municipality with a slight adjustment for median income.

Q. What is the rationale behind the change allowing the provision of direct assistance under extenuating circumstances?

A. At the beginning of the pandemic, there was a strong demand for food and other basic needs. Food security was identified as one of the most common areas for funding requests during the initial round of applications for COVID-19 emergency social services funding.

The new provision will support the need to respond quickly to emerging and changing social needs in the midst of a health emergency like the pandemic. The provision can be applied without the need for a Ministerial Order, avoiding unnecessary delays to implement and allowing for the timely provision of needed resources in times of emergency.

Q. What types of services could I use FCSS monies for in extraordinary circumstances as allowed in the Regulation?

A. Currently the FCSS Regulation does not allow for direct assistance in the form of clothes, money, food or shelter. In a health emergency or other extenuating circumstance, the Minister would determine if there was a need to use the provision and would also identify the type of direct assistance to be provided. In the current pandemic, the primary need identified has been food/food security.

This change will provide flexibility to address social needs in emergency situations.

Q. If enacted by the Minister will FCSS programs be required to provide direct assistance as identified by the special provision?

A. The new provision is intended to assist FCSS programs in providing greater flexibility to address emergent needs during times of extraordinary crisis, emergencies or other extenuating circumstances. Every community is different and needs and circumstances may differ. Individual FCSS programs will continue to make local funding decisions based on the needs and priorities identified in their respective communities.

Q. Why did we extend the Regulation date in 2021 when the expiry date was not until 2022?

A. The current FCSS Regulation expires on June 30, 2022 and requires review to extend or remove the expiry date.

During recent engagements with stakeholders for the FCSS Review, we heard the Regulation is operating as intended in allowing FCSS programs to address the needs and priorities of their communities. The FCSS Review presented the opportunity to address the expiry date along with the development of an accountability framework and avoid the need for a separate Regulation review.

Q. When will the new accountability framework be in place and how will it be communicated to stakeholders?

A. Work on the development of the new FCSS accountability framework will begin this summer with plans to be implemented later this fall. Community and Social Services will ensure FCSS stakeholders are engaged in the development of the accountability framework, have the opportunity to provide input, and are kept informed of its progress.

Q. What happens between now and the July 1, 2021 date when the Regulation changes come into force?

A. The Regulation continues to operate as it currently exists. The Regulation changes, including the new provision, take effect on July 1, 2021.

Good Afternoon

As you know, in fall 2020 Community and Social Services launched a review of the Family and Community Support Services (FCSS) program. The review began with stakeholder engagement focusing on four themes:

- FCSS Mandate;
- Funding Prioritization;
- Enhanced Collaboration and Coordination; and
- Accountability and oversight.

Through the review process, FCSS stakeholders were invited to provide input to the review through an online survey. One of the messages CSS heard from stakeholders through the survey and other communication was the need for flexibility in responding to emerging and changing social needs during extenuating circumstances such as those faced by Albertans during the pandemic.

The review has concluded and will result in the development of a framework to strengthen the FCSS program. The framework, which will be developed in consultation with stakeholders and implemented later this year, will have a stronger focus on prevention and enhanced accountability measures. Throughout the development of the framework, FCSS programs will continue to have avenues for input related to the administration of FCSS funding.

The review also presented the opportunity to make changes to the FCSS Regulation, which was set to expire next year. Regulation amendments were proposed to allow for the provision of direct assistance in the case of a public health emergency under the *Public Health Act* or extenuating circumstances as determined by the Minister, align FCSS audit requirements for review engagements with ministry requirements, and address the expiry date and other minor housekeeping changes.

The Regulation changes will take effect on July 1, 2021 and are outlined as follows:

- Add the flexibility to provide vulnerable Albertans with direct assistance like food provision, during extraordinary times of crisis, such as pandemics or natural disasters. The current regulation does not allow intervention supports.
- Align FCSS audit requirements for review engagements with CSS requirements by changing the threshold for a review engagement report from \$100,000 to \$250,000.
- Repeal section 12 as this section refers to a previous section of the Regulation, which was repealed in 1995 and is no longer required in the current Regulation.
- Improve the consistency of the language in the Regulation around the word "services" to clarify that municipal costs of a program relate to "services provided under the program".
- Extend the expiry date to June 30, 2032.

The Lake Winnipeg DataStream is an open access platform for sharing information on freshwater health. It currently allows users to access, visualize, and download full water quality datasets collected by monitoring groups throughout the Lake Winnipeg watershed which includes the North Saskatchewan River watershed.

Funding for Small Acreage, Hobby Farm and Recreational Property Owners



The Land Stewardship Center, with funding from Alberta's Watershed Resiliency and Restoration Program and support from rural municipalities, has expanded the Green Acreages program and is now accepting applications from small acreage, hobby farm and recreational property owners to fund cost-shared, eligible stewardship initiatives on their properties.

Eligible projects may be funded 50:50 up to a maximum of \$2500 per project on a costshare basis (i.e., property owners must contribute the same or greater cash or in-kind value to the projects). To be eligible, cost-share projects must incorporate beneficial management practices that will lessen the impacts of flooding and drought incidents. For example:

- Projects that enhance natural watershed function
- Riparian zone enhancements through planting and buffers
- Shoreline remediation and/or re-naturalization, such as planting native species, reinforcing shoreline through soil bioengineering and other natural methods
- Erosion reduction measures
- Exclusion fencing, off-site watering systems and stream crossings (e.g., to keep livestock out of water bodies and away from riparian areas)
- Use of native species in planting initiatives





PROPOSED PROVINCIAL POLICE SERVICE RE:

At the last regular meeting of Claresholm Town Council held Monday, May 10, 2021, Council discussed the province's proposed plan to replace the RCMP in Alberta with a provincial police force. The Town of Claresholm has received communication from many other municipalities in Alberta through the Alberta Urban Municipalities Association (AUMA) that are deeply concerned about this proposal, and Council recently met with the National Police Federation who are advocating to keep the RCMP in Alberta.

Municipalities in Alberta continue to be faced with having to provide services and support for our residents while funding streams have been significantly cut. This means that our residents are directly affected financially by choices being made at the provincial level. The Alberta Government has instituted a new police funding model that includes communities under 5,000 such as ours to be charged on an increasing scale for policing that we have never been burdened with directly before. With this being the case, should the municipalities not be in a stronger position to have an impact on decisions that are being made?

The current Alberta Government seems to be very focused on moving towards a greater autonomy away from the federal government and other provinces. Having control over a provincial police force must be very appealing for a government that wants to exert its independence, however the Town of Claresholm is asking your government to reconsider this undertaking and focus on other, more pressing matters instead.

The Town of Claresholm appreciates our local RCMP Detachment and has a good relationship with the members. We feel very comfortable with the service that they provide to our residents. If your government truly cares about Alberta residents, this proposal should not proceed and more focus should be placed on working with the existing police force.

Re: Letter in support of the RCMP

Please accept this letter as Edson Town Council's support for the Royal Canadian Mounted Police (RCMP) and in opposition of the Provincial Government's recent proposal of an Alberta Police Force.

While the Province suggests that the switch from the RCMP to an Alberta Provincial Police Service (APPS) will not cost municipalities more financially, we do not believe this is realistic. Who will bare the cost of this service? Currently, Edson RCMP operate out of a Federally owned building. Should there be a switch to an APPS, who would assume the cost of a new detachment? Not to mention all of the other infrastructure that would be required to build an APPS. It does not seem feasible that these costs would not end up being borne by the municipality and their residents and that these would not exceed the current costs of providing RCMP services, given the significant investments that would be required and the loss of Federal Funding.

Currently, the RCMP is our largest budgetary item, and this cost only keeps growing as the Provincial Government takes away sources of revenue and downloading additional costs to us. The Province has recently decreased the percentage of revenue from fines that municipalities receive. This money was used by the Town to directly offset the cost of policing. Further, just this year we received a bill from the Provincial Government for the provincial portion of Biology Casework Analysis Agreements expenses. A cost that was not the responsibility of a municipality in the past and was given to us with little to no notice. These cuts and downloads increase costs

to our Town by ~\$350,000-\$400,000; equating to a 3.5%-4% tax increase for our residents. Given this, what protections would be in place to ensure municipalities are not continuously charged more under an APPS model? It seems more realistic that it would only be a matter of time before more costs were downloaded to municipalities for operation of the APPS.

We have worked hard as a municipality to build a strong working relationship with our local RCMP Detachment. They are our partners and an integral part of our community. We are happy with the level of service our RCMP provide and their participation within our community.

We strongly encourage the Provincial Government to use the funds dedicated to researching an APPS, towards building stronger relationships with the RCMP and the Federal government to achieve desired outcomes. The Province repeatedly encourages municipalities to work with each other and come up with new and collaborative ways to provide programs and services to our residents in a cost-effective manner. We implore your Government to do the same and work with your Federal counterparts to achieve the Province's goals related to the RCMP and Policing and to emulate the principles in which they ask of municipal governments within the Province.

The Magrath Town Council is disappointed by the Province of Alberta's reluctance to accept the results of its own consultative process by pressing forward with an agenda that appears to want to replace the RCMP with an Alberta Provincial Police Service. Given such, we seek to add our support to the letters sent by the Municipality of Crowsnest Pass, the Town of Morinville, and the County of Paintearth No. 18.

While we are confident that through the hard work of those employed either option would provide high quality police services to Albertans, we are more than a little concerned about the bureaucratic transitional costs that would be needed to complete such a change. Our RCMP detachment serves our community's needs, is consultative with our Council, and is recognizable within our community.

Dear Minister Madu.

Please be advised that Raymond Town Council is opposed to the creation of a provincial police service to replace the RCMP. After reviewing the Fair Deal Panel's Report to Government (as well as the many letters currently circulating from municipal elected officials opposing a provincial police force) Raymond Town Council is voicing its opposition to the proposed provincial police force. There are a couple particularly concerning items identified in the Fair Deal Panel's report, namely:

- the Fair Deal Panel's recommendation to proceed with developing a proposal for a provincial police force, despite only 35% of Albertans believing the police force would contribute to the desired outcome of helping Alberta improve its position in the federation.
- Provincial and municipal governments possibly absorbing \$112 million policing costs currently covered by the federal government (which would be in addition to the increasing policing costs incurred by municipalities under the Police Funding Model).

In these times of increasing public participation and consultation, struggling economies and tighter budgetary realities, we feel the above concerns should have been enough to convince the provincial government not to proceed with researching this issue.

Furthermore, and perhaps most importantly, we have an excellent relationship with our local RCMP force and feel no need to replace them with a provincial force. The RCMP in Raymond have always been responsive to our Council's requests and have consistently delivered professional, quality public safety services in our community.

MEMORANDUM OF AGREEMENT entered into effective this 1st day of January, 2021 BETWEEN:

LAC STE. ANNE COUNTY (hereinafter referred to as the "County")

- and -

ALBERTA BEACH

(hereinafter referred to as the "Alberta Beach")

RECREATION FUNDING AGREEMENT

WHEREAS the County provides funding to recreation facilities within their municipal boundaries and/or within the region;

WHEREAS the County and Alberta Beach have entered into an Intermunicipal Collaboration Framework agreement pursuant to the *Municipal Government Act* ("ICF"), and as part of that ICF intend that any agreement with respect to recreation services will be dealt with through a separate agreement;

AND WHEREAS the County and Alberta Beach wish to set out their agreement with respect to shared funding for recreation services, on the terms and subject to the conditions hereinafter set forth.

NOW THEREFORE THIS AGREEMENT WITNESSETH that the parties hereto in consideration of the mutual covenants and agreements hereinafter set forth covenant and agree with each other as follows:

- 1. This Agreement shall be effective for a term starting January 1, 2021, and ending December 31, 2025. It may be renewed or extended by mutual agreement of the parties.
- 2. The County agrees to contribute to the recreation facilities identified in Schedule "A" to the extent of the amounts described in Schedule "A" to this Agreement. Such payments shall represent the County's full and complete obligation to contribute to recreation services as addressed by the ICF.
- 3. The County shall be responsible for coordinating payments to any third party organizations described in Schedule "A". The County shall have discretion over the timing of payments, provided that the County shall contribute at least the amounts set out in Schedule "A" during each calendar year of the term.
- 4. Notwithstanding the County's commitment to funding as set out in Schedule "A", the payments are subject to the County's policies and procedures for grant funding including with respect to any obligations by the recipients of those funding to provide recognition to the County for their contributions.

- 5. Upon request by either party, both parties agree to meet annually to review the contributions set out in Schedule "A".
- 6. Nothing herein or the contribution of funds by either party shall make such party liable or responsible for any losses, costs, demands or actions of any kind associated with the facilities or activities related to the funding provided by each municipality. Accordingly:
 - a. Alberta Beach indemnifies and holds harmless the County from any actions, damages, losses, demands or costs (including legal costs on a solicitor and his own client basis) arising from any negligence or wrongful actions of the Village or its employees; and
 - b. The County indemnifies and holds harmless Alberta Beach from any actions, damages, losses, demands or costs (including legal costs on a solicitor and his own client basis) arising from any negligence or wrongful actions of the County or its employees.
- 7. Any dispute in relation to this Agreement shall be dealt with pursuant to the dispute resolution provisions set out in the ICF.
