
COVID-19 Status


Cases in Alberta

We are disheartened to see the rates of COVID-19 infection in Alberta continue to trend upward. The average number of daily new cases for the week ending on November 11 is 742, compared to 596 cases the previous week, a 24 per cent increase. On November 12, a record high number of new cases in a single day occurred with 930 new cases. We're seeing the most dramatic increases in infections in people between the ages of 20 to 49, with 2,832 cases in the past week, which is 55 per cent of all new cases.

Across the province, there is a record number of active cases this past week: 8,305 individuals currently have COVID-19 in Alberta, up 26 per cent from the week before. Calgary and Edmonton continue to face intense pressure from high rates of infection with 3,504 and 3,387 active cases, respectively. Calgary's cases account for 42 per cent of the total cases in Alberta, while Edmonton's are 41 per cent.

The graphs below, taken from a report by Alberta Health, visually depict the recent steep rise in cases in our province. The full report details for the graphs below are available here, under the tabs for Total Cases and





Hospital Capacity

The number of individuals being treated for COVID-19 in Alberta hospitals is also very concerning and continues to rise. On November 12, there were 240 individuals in Alberta hospitals – another record number – with 186 of those in non-intensive care units (ICUs) and 54 in ICUs. This is 46 per cent more hospital admissions than we had the week before, when there were 164 individuals in Alberta hospitals, with 130 of those in non-ICUs and 34 in ICUs.

As we see these numbers continue to rise we are carefully monitoring and managing our hospital and ICU capacity.

Currently, capacity at Edmonton and Calgary Zone hospitals is frequently exceeding 100 per cent. Some units are seeing occupancy as high as 125 per cent. Much of this is being driven by the need to isolate COVID-positive patients or close contacts. Between Calgary and Edmonton, we have about 800 isolation beds, however we are currently using about 1,200 isolation beds, meaning some beds in multibed rooms cannot be used.


In addition to this, more than 500 continuing care beds across all five AHS zones are currently closed due to site outbreaks. Patients who would normally be transferred from hospital to a continuing care centre are having to wait longer in hospital. This also limits the number of available hospital beds.

For these reasons, AHS has already initiated new measures in Edmonton to reduce the strain on our hospitals.

In Edmonton, new surge capacity measures were put in place two weeks ago to better support safe patient care. This included postponing up to 30 per cent of scheduled, non-emergency surgeries, and some ambulatory care clinic visits. These measures allow frontline teams to be redeployed to other areas to meet demand and ease pressure points. Taking these steps has helped ease pressure, but we continue to work to meet the demands of capacity and find ways to reduce the pressure on our hospitals.

Calgary Zone and South Zone are planning additional surge capacity measures over the next 7-14 days.

Ultimately, we need Albertans to work hard to reduce the amount of COVID-19 transmission in our communities to ensure we have the capacity to care for those who need it most.



In total, since the start of the pandemic in this province, 393 Albertans have died from COVID-19, including 38 in the current week. We continue to extend our condolences to the families of these individuals, and to all who have lost loved ones during this time.

Here is some other notable information from this past week:

- As of November 11, there has been a total of 36,405 cases of COVID-19 in Alberta, with a total of 1,308 individuals having been hospitalized. This is 3.6 individuals for every 100 cases. In all, 27,707 Albertans have recovered from COVID-19.
- As of November 12, AHS has confirmed 1,610 individuals with COVID-19 were present at schools while infectious or acquired the disease in the school setting. Currently, 597 out of 2,415 schools in the province have reported an individual has attended their school while infectious or had in-school transmission. The Edmonton Zone has the highest numbers of both in-school transmission and schools currently on alert, outbreak or watch.

Please note, we're unable to report on laboratory testing data of COVID-19 numbers this week due to technical issues at Alberta Health.

COVID-19 Testing for Healthcare Workers - The Latest Numbers

We continue to update the testing data for healthcare workers in the AHS Healthcare Worker COVID-19 Testing dashboard. These statistics provide the total number of AHS, Covenant Health and Alberta Precision Laboratories (APL) employees and physicians tested, including a breakdown of the number of positive tests and those who have been confirmed to have been exposed in the workplace.

As of November 10:

- 62,816 employees (AHS, APL and Covenant combined) have been tested for COVID-19 and, of those, 1,205 (or 1.92 per cent) have tested positive.
- Of the 651 employees who have tested positive and whose source of infection has been determined, 186 (or 28.6 per cent) acquired their infection through a workplace exposure. An additional 554 employees who have tested positive are still under investigation as to the source of infection.
- 4,028 physicians (AHS, APL and Covenant combined) have been tested for COVID-19 and, of those, 64 (or 1.59 per cent) have tested positive.
- Of the 42 physicians who have tested positive and whose source of infection has been determined, seven (or 16.7 per cent) acquired their infection through a workplace exposure. An additional 22 physicians who have tested positive are still under investigation as to the source of infection.

Things You Need to Know

Alberta Government Introduces New COVID-19 Restrictions

In an effort to reduce the spread of COVID-19 in Alberta, the Government of Alberta announced new restrictions to specific areas, business and activities in Alberta. Starting November 13, all restaurants, bars, lounges and pubs in regions under enhanced status must cease liquor sales by 10 p.m. and close by 11 p.m. This restriction will remain in place until November 27.

There will also be a two-week ban on indoor group fitness classes, team sport activities and group performance activities in Edmonton and surrounding areas, Calgary and surrounding areas, Grande Prairie, Fort McMurray, Red Deer and Lethbridge.

Additional public health measures will also be implemented in all regions under an enhanced status, including both voluntary and mandatory restrictions related to social gatherings, which will be in place until further notice:

- Maximum attendance of 50 at wedding or funeral ceremonies. Like all social and family gatherings, receptions in association with these ceremonies are limited to 15 people
- It is recommended all faith-based activities limit attendance to one-third capacity per service
- Residents should not hold social gatherings within their homes and should not plan social gatherings outside their community
- It is recommended employers in office settings implement measures to reduce the number of employees in the workplace at one time

Contact Tracing Update

Efficient identification and notification of close contacts of COVID-19 remains critical to Alberta's fight against COVID-19. Rapid notification of close contacts ensures that those exposed can isolate and get tested before potentially spreading disease to others.

On November 12, a new Alberta Health Services online tool was announced that will allow automated texting of close contacts of positive COVID-19 cases in our province.

Albertans who receive a positive COVID-19 result will now be asked to immediately visit ahs.ca/closecontacts and click on the COVID-19 Close Contact Tool, where they will enter information, including phone numbers of known close contacts. Once submitted, our contact tracing team will review all close contacts with the positive case, and an automated text message notification, including additional guidance and instructions, will be delivered to all close contacts whose phone numbers are provided.

The confidentiality of positive cases will be protected – they will not be identified in these text messages.

This tool will further support Albertans as they collaborate with our Contact Tracing team on notification of close contacts. It will also improve the efficiency of contact notifications.

As announced on November 5, AHS will also continue to directly contact all close contacts of cases in healthcare workers, minors (parents will be notified if their child has been exposed in a school setting), and individuals who live or work within congregate or communal facilities, through either phone or email.

School-related contacts will continue to receive email notification from AHS, and workplaces and <u>organizers of events</u> of 10 or more attendees will also still be asked to notify the appropriate staff and all attendees, respectively.

In addition to this new online tool, AHS has also posted 425 new positions for hiring onto the contact tracing team. All positions can be viewed online at ahs.ca/contacttracingjobs.

We also encourage Albertans to download the <u>Alberta Trace Together app</u>, which provides our contact tracing teams with another source of information when working with Albertans to identify close contacts.

As we work to deploy information, innovative approaches and new staff, it also remains critical that all Albertans limit their social bubble, and follow all other public health guidance.

Updates to Designated/Family Support and Visitor Access in AHS Acute Care Facilities
Effective November 16, access to AHS acute care sites for the purposes of visitation is limited to designated family/support persons. Visitor access is restricted for patients at end-of-life and for those receiving critical care for a life-threatening illness. Exceptions will be made for faith/religious leaders, elders, an elder's helper, traditional knowledge keeper or legal supports who are requested by the patient or alternate decision-maker. These visits must be booked in advance with the service area.

This decision was not made lightly. We must do all we can to protect our patients, and the staff caring for them. We recognize that family and loved ones play an important role in the emotional and physical well-being of our patients, and will work with families and facilities to continue to support virtual visitation.

We are also encouraging staff, patients/residents, and designated family/support persons to work together to reduce the amount of time spent in AHS facilities by considering what support needs to be provided in person and what can be provided virtually. Designated family/support persons should assess their risk of exposure and transmission of COVID-19 before they enter an AHS site. To support this, we have created two brochures for designated family/support persons: Know Your Risk and Know Your Role.

As we continue to see a rise in COVID-19 cases across the province, changes have been made to the Access Guidance including ambulatory appointments (for both pediatrics and adults), replacement support persons, outdoor visitation, patient off-site passes and Indigenous considerations during a patient's care journey. Influenza Immunization Update

More than one million doses of influenza vaccine have been administered in Alberta, an increase of more than 200,000 doses from last week. To date, there have been no reported cases of seasonal influenza. The third weekly influenza data report is now available at ahs.ca/influenza.

This is a great start to the season. However, with the cases of COVID-19 on the rise, we need to continue to do what we can to keep influenza out of our healthcare system, so we can focus on COVID-19.

In addition to influenza immunization, public health measures such as <u>physical distancing</u>, <u>masking</u>, <u>limiting</u> <u>your social bubble</u> and maintaining <u>hand hygiene</u> continue to be critical to our fight against COVID-19 and other cold and flu-like illnesses, including influenza.

New general surgeon, family physician recruited to St. Paul

A new general surgeon is expected to begin practising in St. Paul in February, and will be moving here with family from Saskatchewan in the coming months. Recruitment for this position began last month after the town's previous general surgeon announced a move to Cold Lake.

A new family medicine physician has also been recruited and is expected to be working in St. Paul by April. This physician will be joining the community from overseas and AHS is currently working closely with the physician and the College of Physicians and Surgeons (CPSA) to finalize details. AHS will update the community as more information becomes available.

Recruitment has been ongoing for other physician vacancies in St. Paul, including two family medicine physicians with low-risk obstetric skills. All vacancies are posted online at www.doctorjobsalberta.com.





COVID-19 Status

Cases in Alberta

Alberta reached a troubling milestone this past week when, for the first time, the province surpassed 1,000 daily new COVID-19 cases — not just once but three times, with 1,036 cases reported on Nov. 13, 1,107 cases Nov. 18 and 1,155 Nov. 19. Overall, the average number of daily new cases for the week ending on Nov. 18 is 913, compared to 741 cases the previous week, a 23 per cent increase. Over that period, there were 3,622 cases among individuals aged 20 to 49 years, which is 57 per cent of all new cases.

Sadly, there's another grim milestone to report. The number of active cases in the province surpassed 10,000 this week. As of Nov. 18, there are 10,382 active cases. The Edmonton Zone leads with 4,388 active cases, accounting for 42 per cent of all active cases. The Calgary Zone is close behind with 4,219 active cases, accounting for 41 per cent of all active cases.




Hospitalizations and ICU admissions

The record numbers of new daily cases and active cases continue to drive up our hospitalization and ICU numbers, with both measurements hitting new highs this past week. On Nov. 17, there was a record number of 293 of individuals being treated in Alberta hospitals with 59 in ICU. Currently, there are 284 hospitalizations, with a record 61 in ICUs. This is 36 per cent increase in total hospital admissions from the previous week ending Nov. 11.

AHS has the ability to create temporary ICU space in spaces that would otherwise be used to care for patients who have other conditions requiring specialized care, such as coronary care and post-operative recovery, and from other areas able to support ventilators and cardiac monitoring. In Edmonton and Calgary, 20 beds are being added in both zones. More ICU and acute care beds will be added in the days and weeks to come.

AHS has been training additional staff in the use of ventilators, an intervention that is needed in approximately 60 to 80 per cent of COVID-19 patients admitted into an ICU.



Other notable COVID-19-related information

- As of Nov. 18, a total of 42,797 cases of COVID-19 have occurred in Alberta and a total of 1,516 individuals have been hospitalized, which amounts to 3.5 individuals for every 100 cases. In all, 31,964 Albertans have recovered from COVID-19.
- Since the start of the pandemic in this province, 451 Albertans have died from COVID-19, including 58 in the current week. We extend our condolences to the families of these individuals, and to all who have lost loved ones during this time.
- Alberta Health is still experiencing some issues with its laboratory testing data of COVID-19 but
 we know that there have been a total of 1,388,093 people tested at least once for COVID-19, and
 a total of 2,051,622 tests performed by the lab.
- As of Nov. 19, AHS has confirmed 1,806 individuals with COVID-19 were present at schools
 while infectious or acquired the disease in the school setting. Currently, about one in four schools
 in the province (649 of 2,415) has reported an individual attending the school while infectious or

COVID-19 Testing for Healthcare Workers - The Latest Numbers

We continue to update the testing data for healthcare workers. These statistics provide the total number of AHS, Covenant Health and Alberta Precision Laboratories (APL) employees and physicians tested, including a breakdown of the number of positive tests and those who have been confirmed to have been exposed in the workplace.

As of Nov. 18:

 64,143 employees (AHS, APL, and Covenant combined) have been tested for COVID-19 and, of those tested, 1,451 (or 2.26 per cent) have tested positive.

- Of the 666 employees who have tested positive and whose source of infection has been
 determined, 191 (or 28.6 per cent) acquired their infection through a workplace exposure. An
 additional 785 employees who have tested positive are still under investigation as to the source
 of infection.
- 4,109 physicians (AHS, APL, and Covenant combined) have been tested for COVID-19 and, of those tested, 74 (or 1.8 per cent) have tested positive.
- Of the 42 physicians who have tested positive and whose source of infection has been determined, seven (or 16.7 per cent) acquired their infection through a workplace exposure. An additional 32 physicians who have tested positive are still under investigation as to the source of infection.

COVID-19 testing is offered to eligible Albertans by appointment only. If you are symptomatic, a close contact of a confirmed case of COVID-19, or have been linked to a confirmed outbreak of COVID-19, please visit ahs.ca/covid to complete the self-assessment and book your testing appointment. All locations available to you, including any of the new mobile assessment centres, will be displayed in the online booking tool. If you do not have Internet access, you can call 811 and Health Link staff will book a test appointment for you.

We remind anyone who has booked, but cannot make, a COVID-19 testing appointment to please cancel or change it so someone else can book that spot. If you booked your spot online and have a confirmation number, go to ahs.ca/mybooking and enter your confirmation number and postal code to make a change or click the link provided in your confirmation email.

Influenza Immunization Update

More than 1.2 million doses of influenza vaccine have been administered in Alberta, an increase of more than 93,000 doses from last week. To date, there have been no reported cases of seasonal influenza. The fourth weekly influenza data report is now available at ahs.ca/influenza.

This continues to be a great start to the season. However, with cases of COVID-19 on the rise, we need to continue doing what we can to keep influenza out of our healthcare system, so we can focus on COVID-19.

Now more than ever, each of us must do our part to protect ourselves, our families and vulnerable members of our society from any illness, including influenza. Getting immunized against the flu is one simple action we can all take to reduce the chance of getting sick and prevent the spread illness to others while also helping to limit the strain on our healthcare system.

Attend a local pharmacy, doctor's office or public health clinic. Check ahs.ca/influenza for age eligibility, vaccine availability and other details about this year's public health flu campaign.

While there are no reported cases of influenza yet, it's important to take influenza seriously. It's an illness that can have devastating consequences for people who are immunocompromised, pregnant, seniors, young children and those with chronic health conditions.

Accreditation Canada Commends AHS Staff & Physicians

In fall 2020, accreditation activities across the province resumed, focused on urban and regional hospital programs (emergency department, inpatient (medicine) services, peri-operative and invasive procedures, and transplant care), EMS services, as well as provincial Corrections Health and South Zone rural hospitals (both deferred from spring).

Accreditation Canada surveyors conducted more than 900 interviews at 64 locations. Surveyors felt confident the care being provided was truly a standard, acknowledging the unwavering dedication of our staff to providing quality care throughout the pandemic.

The surveyors highlighted our caring, compassionate people and the collaboration that occurs at all levels of the organization. The demonstrated ability to balance many important priorities, including Connect Care implementation as well as quality and safety work, while at the same time delivering excellent patient care, is commendable.

With rising numbers of new COVID-19 cases, hospitalizations and ICU admissions, Albertans are being urged to avoid gatherings, wear masks in public, maintain physical distancing and wash their hands regularly. Straight Talk is a video series in which public health messages are being delivered by healthcare workers, who talk from the heart about what they're seeing and experiencing at work and in their communities as the virus spreads across the province.

Staff and physicians at the Three Hills Health Centre extend a heartfelt thank you to community member Melvin Wright and the Three Hills Health Care Auxiliary for their collaboration in purchasing the Rifton TRAM for the physiotherapy department. This multipurpose lift is used for gait training and safely transferring patients onto exercise equipment for their rehab programs.

Wright, 89, singlehandedly raised \$6,000 towards the \$13,000 cost of the TRAM, with the auxiliary raising the remainder. The longtime Three Hills resident has participated in 23 fundraisers and has raised thousands of dollars for various causes with no plans to slow down anytime soon.



COVID-19 Status

Cases in Alberta

For the first time, Alberta reported more than 1,000 new cases of COVID-19 every day over the past week as active case numbers, hospitalizations and ICU admissions all continued to rise.

There was an average of 1,295 daily new cases for the week ending on Nov. 25, compared to 912 cases the previous week, a 42 per cent increase. The province also reported a record 1,569 new cases on Saturday, Nov. 21. As of Nov. 25, there are 14,052 active cases in the province. All zones reported an increase in active cases this past week, with Central Zone experiencing an 86 per cent increase from the previous week. Edmonton Zone has the most active cases with 6,444 as of Nov. 25, compared to 4,388 active cases the previous week, a 47 per cent increase.



The table below shows the number of active cases for the previous and present week for each zone:



From Nov. 19 to Nov. 25, there were 4,953 cases among individuals aged 20 to 49 years, which is 55 per cent of all new cases. There were 1,249 cases among individuals aged 60 years and older; several of these cases are associated with outbreaks in long-term care facilities.

Hospitalizations and ICU admissions

As of Nov. 25, there are 383 individuals being treated in Alberta hospitals for COVID-19, with 84 in intensive care units (ICUs) — both are all-time highs. This is also a 35 per cent increase in total hospital admissions from the previous week ending Nov. 18.

The province introduced additional public health measures this week to respond to COVID-19 spread, and to protect the health of Albertans and the capacity of the healthcare system. See our Wrapping Up item at the bottom of this email for details on these measures.



Other notable COVID-19-related information:

- As of Nov. 25, a total of 51,878 cases of COVID-19 have occurred in Alberta and a total of 1,713 individuals have been hospitalized, which amounts to 3.3 individuals for every 100 cases. In all, 37,316 Albertans have recovered from COVID-19.
- As of Nov. 25, 510 Albertans have died from COVID-19, including 59 in the past week. We
 extend our deepest sympathies to the families of these individuals, and to all who have lost loved
 ones from any cause during this time.
- In the past week, 121,113 COVID-19 tests were completed, an average of 17,302 per day. A record number of tests was reached this past weekend with 19,484 and 19,486 tests performed on Nov. 21 and Nov. 22, respectively. The daily positivity rate was above six per cent for the entire week of Nov. 19 to Nov. 25, and hit a record of 8.34 per cent on Nov. 23. A total of 2,173,038 tests have been conducted as of Nov 25.

As of Nov. 26, AHS has confirmed 2,231 individuals with COVID-19 were present at schools while infectious or acquired the disease in the school setting. Currently, 752 out of 2,415 schools in the province have reported an individual has attended their school while infectious or had in-school transmission. Since September, 21 students from Alberta schools have been hospitalized for COVID-19.

These statistics provide the total number of AHS, Covenant Health and Alberta Precision Laboratories (APL) employees and physicians tested, including a breakdown of the number of positive tests and those who have been confirmed to have been exposed in the workplace.

As of Nov. 25:

- 65,844 employees (AHS, APL, and Covenant combined) have been tested for COVID-19 and, of those tested, 1,749 (or 2.67 per cent) have tested positive.
- Of the 842 employees who have tested positive and whose source of infection has been determined, 279 (or 33.1 per cent) acquired their infection through a workplace exposure. An additional 907 employees who have tested positive are still under investigation as to the source of infection.
- 4,215 physicians (AHS, APL, and Covenant combined) have been tested for COVID-19 and, of those tested, 86 (or 2.04 per cent) have tested positive.
- Of the 44 physicians who have tested positive and whose source of infection has been determined, seven (or 15.9 per cent) acquired their infection through a workplace exposure. An additional 42 physicians who have tested positive are still under investigation as to the source of infection.

Things You Need to Know

Acute Care Capacity Increase Planning

As case numbers continue to rise, including rates of hospitalizations and ICU admissions, we are increasing capacity across the health system to provide care spaces for patients with COVID-19.

Over the next several weeks, approximately 2,250 acute care beds and 425 ICU beds will be allocated for patients with COVID-19 across the province if needed. In some cases, these will be new beds and, in other cases, these beds are existing hospital spaces that will be made available as patients are moved into continuing care beds in the community. We are also repurposing other clinical areas to provide ICU care.

In order to allocate these acute and ICU beds, we will also be working with Alberta Health, continuing care operators and other partners to open additional continuing care beds in the community. Some of this capacity work involves transferring patients out of acute care or moving patients within the province and also continuing to reduce services such as ambulatory care and surgery to reduce non-COVID-19 bed and staffing needs. Each zone is creating a specific plan to increase capacity; watch for zone-specific communication updates in the next few days.

We recognize this pandemic has and continues to cause immense strain not just on the healthcare system but on staff as well. As we address surge capacity concerns, we are advancing aggressive recruitment and staffing strategies to ensure we are able to staff the beds. These efforts include

expediting access to potential supply pools, including retirees and students as well as working with Alberta companies that may have suitable and available workforces. We are also increasing hours for trained part-time and casual staff and redeploying trained staff to other areas, so the most critical areas of care are covered.

APL and Partners to Pilot Point-of-Care Rapid Testing

Alberta Precision Laboratories (APL) will begin piloting point-of-care rapid testing for COVID-19 in clinical settings in December, providing Albertans with faster, more convenient testing for the disease.

Over the last few months, the medical teams at APL have been working to evaluate the effectiveness of two different COVID-19 testing kits, which have been approved by Health Canada and provided to provinces and territories by the Public Health Agency of Canada. In the coming weeks, these two point-of-care rapid testing systems will be rolled out in clinical pilots at several sites throughout the province, including in Calgary, Edmonton, Slave Lake, St. Paul and Bonnyville.

The tests will be used for patients who are within the first seven days of exhibiting symptoms, enabling APL to quickly identify positive cases at testing sites, reducing the need for patient samples to be transported to centralized public laboratories for processing.

APL is also working on expanding the use of point-of-care testing in other locations where it can be of the greatest value for public health authorities to manage COVID-19, such as homeless shelters and long-term care facilities.

Updates to Visitation during Outbreak and High Community Transmission

This week AHS made changes to designated family support and visitation guidelines at acute care facilities on outbreak and in communities where COVID-19 transmission is high.

These changes include:

- Only one designated family/support person is permitted under <u>specific circumstances</u> for patients admitted to hospital.
- In addition, there is guidance for specific patient care areas:
 - Maternity and postpartum: one designated family/support person is permitted. A doula
 or a surrogate, in addition to the designated family/support person, will be allowed when
 this is part of a birth plan and the facility has the ability to support this safely.
 - Pediatrics and NICU: up to two designated family/support persons are permitted.
 - Critical care: up to two designated family/support persons are permitted.
 - End-of-life: one designated family/support person. The presence of visitors must be prearranged with the site/unit.
 - Ambulatory (outpatient): one designated family/support person, where possible.
 - Emergency department: one designated family/support person, where possible.

The extent of restrictions will vary site-to-site due to patient circumstances, operational considerations and ability to maintain physical distancing. We recognize these restrictions are difficult for patients, families, loved ones, staff and physicians. These are temporary measures to help reduce the exposure and spread of COVID-19.

Additionally, we are encouraging staff, patients/residents, and designated family/support persons to work together to reduce the amount of time spent in AHS facilities by considering what support needs to be provided in person and what can be provided virtually. Two brochures have been created for patients, residents and support persons to review: Know Your Risk and Know Your Risk and Know Your Risk and Know Your Role.

Contact Tracing Adjustments Aim to Reduce Backlog

With the significant increase in new COVID-19 cases over the past several weeks, AHS has made adjustments to our contact tracing process to keep up with demand and reduce the current backlog of Albertans waiting for a follow-up call.

Effective Nov. 24, AHS is no longer calling Albertans to conduct case investigation and contact tracing if 10 days have passed since their symptom onset or since the date of their COVID-19 swab, dependent on which information is available. Instead, this group will receive a text message that will notify them to not

expect a call AND provide them with guidance on if and when their isolation period has ended.

In addition, to further reduce this backlog now and going forward, all Albertans who test positive for COVID-19 will receive a text message to notify them when their isolation period has ended.

AHS has automated this release-from-isolation service to enable contact tracers to spend their time contacting Albertans where we can have the greatest impact on preventing transmission and serious outcomes. Previously, AHS contact tracers made these release-from-isolation calls personally.

The text messages sent in both situations outlined above are similar and will provide a link to ahs.ca/isolation on the AHS website for more information on isolation requirements, testing options, symptoms and supports available.

Changes to Online Assessment Tool

Public health will have a new, streamlined way to help anyone connected with an outbreak throughout the province with changes coming to the online assessment tool. Effective today, Nov. 30, Albertans who are connected to an outbreak will be given an outbreak (EI) number and then directed to book an appointment for a COVID-19 test through the AHS online assessment tool. The linkage through an EI number will reduce the workload of CDC and Health Link, and will allow public health to monitor the outbreaks more efficiently.

Verna's Weekly Video Message — Vaccine on the Horizon

Nearly nine months have passed since the first confirmed case of COVID-19 in Alberta. We know this pandemic has been difficult for us all, and we thank each and every one of you for your compassion and dedication.

And now there is some promising news on the horizon.

Last week, the drug maker Moderna announced its COVID-19 vaccine is 94.5 per cent effective. That follows Pfizer's announcement that its vaccine candidate was found to be more than 95 per cent effective in preventing COVID-19.


COVID-19 assessment site open in Chestermere

"I wish that people would just take things more seriously," says Bernier. "You need to just stay home. I know it's hard, it's affecting people's mental health greatly. But we basically are in this together and we have to get through it together."



Wrapping Up

This week brought additional public health measures from government to protect the health of Albertans and the capacity of the healthcare system. Let's make sure we adhere to these measures ourselves, and encourage our families, friends and neighbours to do the same.

For those who didn't hear about the new measures, they call for:

- No indoor social gatherings, public or private, and no more than 10 people at outdoor social gatherings.
- Maximum of 10 people for wedding ceremonies and funeral services. This does not include staff or organizers who are not considered invited guests. Receptions are not permitted.
- Mandatory masking in all indoor workplaces in Calgary, Edmonton and surrounding areas.
- Restricted capacity to 25 per cent of the occupancy set under the Alberta Fire Code in communities under an enhanced status for most retail businesses and for some entertainment and event services.
- No more than six people, all of whom must be from the same immediate household, at a table in restaurants, bars, pubs and lounges and no movement between tables.
- A move to at-home learning, starting Monday, for all students in Grades 7 to 12, with a
 resumption of in-person learning starting on Jan. 11. K-6 students will move to in-home learning
 after the winter break until Jan. 8, resuming in-person classes on Jan. 11.
- Ending in-person service in regions under enhanced status for banquet halls, conference centres, trade shows, concert venues, children's play places, indoor playgrounds and all levels of team and individual sport.

We also must continue to adhere to, and promote, existing public health measures that we surely all know by heart by now: wash your hands regularly with soap and warm water, or hand sanitizer; do not touch your face with unclean hands; wear a mask in public places; maintain two metres of physical distancing from people not in your cohort; limit your social bubble — and, if you haven't already, get your seasonal influenza immunization. By keeping the number of influenza cases low, we are doing our part to help healthcare workers focus on the COVID-19 pandemic.

Finally, please take care of yourselves and each other. This has been a long, hard year and much of what we've faced is out of our control. However, we can choose to give ourselves and each other permission to be human. Not heroes. Human. Humans who get tired. Humans who can get grumpy. Humans who are never perfect all the time. Human who need to cry, need a hug, need a laugh, or need help and support from others at some point. Give yourselves permission to be all that; be kind, generous and forgiving to yourself and others.



COVID-19 Status

Cases in Alberta

The spread of COVID-19 in the province showed no signs of slowing down last week (Nov. 26-Dec. 2), as Alberta set highs for daily new cases, hospitalizations and ICU admissions.

Over those seven days, more than 1,200 new cases were reported each day, with records set on Nov. 27 and Dec. 2: 1,730 and 1,861 new cases respectively. There was an average of 1,596 new daily cases, compared to 1,295 the previous week, a 23 per cent increase. There were 6,226 cases among individuals ages 20 to 49 years, which represents 56 per cent of all new cases.




Four of the five zones reported an increase in active cases; South Zone being the exception. Edmonton Zone continues to have the most active cases with 8,331, a 29 per cent increase over the previous week. Central Zone reported a 32 per cent increase in active cases, the largest proportional increase among the zones.

The table below shows the number of active cases in each zone for the last two weeks.

Hospitalizations and ICU admissions
The number of individuals being treated for COVID-19 in Alberta hospitals continues to trend upward. As of Dec. 2, there are a record 511 individuals being treated in Alberta hospitals for COVID-19, with 97 in ICUs. The highest number of COVID-19 patients in the ICU since the start of the pandemic, with 101.



Other notable COVID-19-related information:

- As of Dec. 2, a total of 63,023 cases of COVID-19 have occurred in Alberta and a total of 2,038 individuals have been hospitalized, which amounts to 3.2 individuals for every 100 cases. In all, 44,705 Albertans have recovered from COVID-19.
- Alberta has reported 575 deaths since the start of the pandemic, including 65 in the past week.
 We extend our condolences to the families of these individuals, and to all who have lost loved ones from any cause during this time.
- In the past week, 135,729 COVID-19 tests were completed, an average of 19,389 per day. A
 record number of tests were performed Nov. 27 and 28: 21,693 and 23,317, respectively. The
 daily positivity rate reached 9.46 per cent on Dec 2. A total of 2,309,153 test have been
 conducted as of Dec 2.
- As of Dec 3, AHS has confirmed 2,681 individuals with COVID-19 were present at schools while
 infectious or acquired the disease in the school setting. As of Dec. 2, 831 out of 2,415 schools in
 the province have reported an individual has attended their school while infectious or had inschool transmission. Since September, 22 students from Alberta schools have been hospitalized
 for COVID-19 with two being treated in ICUs

COVID-19 Testing for Healthcare Workers - The Latest Numbers

We continue to update the testing data for healthcare workers. These statistics provide the total number of AHS, Covenant Health and Alberta Precision Laboratories (APL) employees and physicians tested,

including a breakdown of the number of positive tests and those who have been confirmed to have been exposed in the workplace.

As of Dec. 2:

- 67,523 employees (AHS, APL, and Covenant combined) have been tested for COVID-19 and, of those tested, 2,087 (or 3.09 per cent) have tested positive.
- Of the 899 employees who have tested positive and whose source of infection has been determined, 296 (or 32.9 per cent) acquired their infection through a workplace exposure. An additional 1,188 employees who have tested positive are still under investigation as to the source of infection.
- 4,331 physicians (AHS, APL, and Covenant combined) have been tested for COVID-19 and, of those tested, 98 (or 2.26 per cent) have tested positive.
- Of the 44 physicians who have tested positive and whose source of infection has been determined, seven (or 15.9 per cent) acquired their infection through a workplace exposure. An additional 54 physicians who have tested positive are still under investigation as to the source of infection.

Things You Need to Know

APL Launches Clinical Pilot Involving Rapid Point-of-Care COVID-19 Testing
Starting Friday at the hospital lab in Bonnyville, Alberta Precision Laboratories (APL) began piloting pointof-care rapid testing for COVID-19, providing faster, more convenient testing for the disease.

Patients who are within the first seven days of exhibiting symptoms are eligible for testing, allowing APL to quickly identify and notify positive cases within hours. This will speed up the appropriate care and isolation of patients, which will help reduce the spread of the virus in our communities. It will also divert many positive samples from the volumes going to the lab, which will help reduce turnaround times for COVID-19 tests overall.

Rapid point-of-care testing also began this week at COVID-19 assessment centres in Slave Lake and St. Paul, as well as one assessment centre in both Calgary and Edmonton.

These pilots will inform APL and AHS on how to streamline processes related to patient management, results notifications and digital record-keeping before the tests are deployed widely across the province, to ensure accuracy and enhanced turnaround times while alleviating pressure on our labs.

COVID-19 Vaccine Update

We are witnessing the toll COVID-19 has taken on our communities. As we have seen with many infection agents, vaccines are a critical way to limit the spread of a virus. They are effective and safe for protecting our health, as well as the health of family and community members.

As announced by the <u>Government of Alberta</u> earlier this week, once COVID-19 vaccines have been approved by Health Canada, Alberta will begin receiving vaccine doses by early next year. Specialized vaccination centres are being set up across the province, and distribution plans on how the vaccine will be distributed are being finalized.

AHS is working closely with Alberta Health to ensure higher-risk populations - including seniors in long-term care facilities and healthcare workers caring for COVID-19-positive and other vulnerable patients in high-risk situations - are prioritized for early COVID-19 vaccination.

Verna's Weekly Video Message — Updated Family Support and Visitation Guidelines
As we all know, family and loved ones play an essential role in the emotional, physical and mental wellbeing of patients and residents. We continue to work with families and facilities to welcome family
presence and visitation wherever we can. But the daily rise in COVID-19 cases, including outbreaks at our

facilities, is a growing concern to the safety of everyone.

Our teams are working hard to ensure patients and staff remain safe and stop further spread of the virus. Part of that involves regularly reviewing our family support and visitation guidelines, and adjusting them to reflect the current evidence and COVID-19 transmission in Alberta.

That's why, last week, we made the difficult decision to place further limits on the number of designated family/support persons permitted at facilities with outbreaks and in areas of high community transmission.

Joining me (Verna) to talk more about these changes are two familiar faces from the Family Presence and Visitation Taskforce:

- Dr. Jim Silvius, Senior Medical Director, Provincial Seniors Health and Continuing Care.
- Paul Wright, Manager, Calgary Zone, Patient and Family-Centred Care.

Request for Proposals issued for Community Lab Services

Alberta Health Services (AHS) and Alberta Precision Laboratories (APL) issued a Request for Proposals (RFP) seeking private-sector partners to provide community lab services across Alberta on Friday, December 4. The RFP process is about finding partners that can help deliver high-quality laboratory services for all Albertans, sustainably and efficiently.

Contracting of community lab services is an opportunity for innovation and potential cost savings identified by the <u>AHS Performance Review</u>. The RFP includes the contracting of community-related laboratory collections, logistics and testing in urban centres and large rural communities to a private provider.

Approximately 65 per cent of provincial lab work, or 50 million tests per year, is generated from the community and will be transitioned to the successful proponent(s).

AHS Continues to Hire Contact Tracing Staff

AHS has continued to enhance our contact tracing teams to meet demand. We are rapidly increasing our response to the unprecedented volume of COVID-19 cases in the province. Pre-pandemic AHS had 50 contact tracers. We increased this 5x by July to 300 and more than doubled it again by September to 700. We now have more than 800 contact tracers in Alberta and are on track to double it once more, bringing us close to 1,600 contact tracers by the end of 2020.

We are currently in the process of going through the offer process, onboarding, and scheduling orientation

for more than 500 additional staff, and a small group have already started working in contact tracing. This work puts us well on track to having approximately 1,600 staff on the contact tracing team by the end of the year. This means we will have 36 contact tracers per 100,000 people, which will be on par or better compared with other provinces.

We are prepared to meet the changing demands of COVID-19 with our increased numbers of dedicated staff, as well as innovative solutions of web portals, online booking and SMS text notifications.

New Grande Prairie Regional Hospital Named

The Government of Alberta has announced Alberta's new hospital will be named the Grande Prairie Regional Hospital. The name was chosen by the Ministry of Health following in-person and online engagement sessions with staff, physicians, volunteers, partners and regional stakeholders.

Since AHS took possession of the building this summer, teams have been busy working through the operational planning and commissioning phase of the project. This includes ordering and installation of furniture and equipment; detailed cleaning of the entire building; training staff to use the new equipment and systems; and thorough



testing of all the medical and operational systems in order to ensure everything is safe and working properly before being used to provide patient care.

A second phase of construction at the new hospital is currently underway, adding a 28-bed mental health unit and a 32-bed medical unit. In addition, design work has begun on two operating suites, supported by the Alberta Surgical Initiative. These two new suites will bring the total number of ORs at the site to 11, including a dedicated maternity operating room.

Emergency Departments (EDs) Visits

Visits to EDs across Canada declined by almost half the usual number of patients early in the pandemic. By the end of June 2020, visits remained lower than is typical for that time of year (about 85% of June 2019 volumes). Visits to EDs across Alberta also declined by almost half the usual number of patients. By the end of June 2020, visits remained lower than is typical for that time of year (about 80% of June 2019 volumes). These findings are consistent with the experience in other countries. In England, for example, ED visits dropped by more than 50%. In Alberta we are now seeing a return to normal ED volumes.

While there are many factors to this, one likely reason for this decrease is that people were anxious or nervous to visit an ED or hospital during this time. We understand why people may have been anxious to visit an emergency department. However, our hospitals and emergency departments remain a safe place to come and to receive care — there is no increased risk to patients coming to hospital.

AHS healthcare facilities follow rigorous Infection Prevention and Control standards. All healthcare workers are asked to self-assess for COVID-19 symptoms and exposure risk using a screening tool before reporting to a site for their shift, and our frontline teams are practicing continuous masking while at work. Any patient with symptoms, or who has tested positive for COVID-19, is isolated away from other patients. And, stringent visitor restrictions are in place, minimizing any risk of transmission from outside of the hospital.

If you think you have a serious or life-threatening injury or illness, go straight to an emergency department or call 911 immediately.

Influenza Immunization Update

More than 1.3 million doses of influenza vaccine have been administered in Alberta, an increase of more than 39,000 doses from last week. For the sixth week in row, there are no reported cases of seasonal influenza in Alberta. The weekly influenza data report is available at ahs.ca/influenza.


Here is another Straight Talk video, featuring Jocelyn Wensley, a registered nurse in the emergency department of Chinook Regional Hospital in Lethbridge.

This morning Alberta Precision Laboratories (APL) and Alberta Health Services (AHS) issued a Request for Proposals (RFP) seeking private-sector partners to provide community lab services across Alberta.

As we have discussed during the last year, the RFP process is about finding partners that can help deliver high-quality laboratory services for all Albertans, sustainably and efficiently. Contracting of community lab services is an opportunity for innovation and potential cost savings identified by the AHS Performance Review. Issuing the RFP is part of the implementation plan for the Performance Review that was approved by the Government of Alberta earlier this year.

The RFP scope includes the contracting of community-related laboratory collections, logistics and testing in urban centres and large rural communities. The private-sector provider(s) would also support some hospital lab testing for those tests not performed on-site at hospitals. Additional components where the new private provider will also need to continue to support are research and training.

In order to ensure that small rural and remote communities continue to receive the service they need, hospital sites that currently handle less than 25,000 community blood test collections per year will continue to do so by APL. Larger communities will expect to be serviced by the private provider(s) through community collection sites.

APL will also continue to deliver all other laboratory services, including direct operation of laboratories located in acute care and urgent care facilities operated by AHS, Covenant Health and Lamont Health Care Centre. Other services that will remain with APL include the public health laboratory, the genetics laboratories and other specialty testing services.

We are pleased to say that the RFP is designed to minimize impact on APL's workforce during the potential transition. The successful proponent(s) will be required to assume all impacted unionized, non-unionized and medical staff on the same or similar terms and conditions as exist prior to transition.

Laboratory testing is critical to the diagnosis and management of patient health, which requires highly trained technical staff and medical experts. Our staff have played a critical role in Alberta's response to COVID-19, and their expertise will be important in ensuring the quality and consistency of lab service is maintained across the province.

The RFP will close in early 2021, and a contract is expected to be awarded in spring 2021, with full transition of community lab work transitioned to the successful proponent(s) in 2022.

The evaluation of proposals we receive from private-sector proponents will include a detailed analysis by a panel that includes medical/scientific experts, laboratory operations professionals and financial analysts.

Our top priority during the evaluation process will be to ensure the safety, quality and service levels of community lab services are maintained and enhanced for all Albertans. We want to reinforce that proceeding with an RFP is not about the quality of the work currently done by our teams. It is about exploring opportunities to enhance the sustainability of laboratory services – as one component of the integrated healthcare system – in Alberta.

Request for Proposals Issued for Community Lab Services

December 4, 2020

Alberta Health Services and Alberta Precision Laboratories (APL) have issued a Request for Proposals (RFP) seeking private-sector partners to provide community lab services across Alberta.

The RFP process is about finding partners that can help deliver high-quality laboratory services for all Albertans, sustainably and efficiently. Contracting of community lab services is an opportunity for innovation and potential cost savings identified by the AHS Performance Review.

"AHS continues to pursue innovative approaches of delivering critical healthcare services more efficiently while enhancing the level of care for all Albertans," says Tyler Shandro, Minister of Health. "Any savings realized through contracting community lab services will be invested elsewhere in the healthcare system, ensuring that use of healthcare dollars addresses the greatest areas of need in Alberta."

The RFP includes the contracting of community-related laboratory collections, logistics and testing in urban centres and large rural communities to a private provider. Approximately 65 per cent of provincial lab work, or 50 million tests per year, is generated from the community and will be transitioned to the successful proponent(s).

"Alberta's growing and aging population means we need to be more efficient and focused in terms of healthcare spending," said Dr. Verna Yiu, President and Chief Executive Officer, AHS. "We need to seek opportunities for innovation and consider ways of doing things differently to ensure Albertans continue to receive the highest quality of laboratory care, and the greatest value from every dollar invested in the healthcare system, both now and in the years ahead."

The RFP is designed to minimize impact on APL's workforce during the potential transition. The successful proponent(s) will be required to assume all impacted unionized, non-unionized and medical staff on the same or similar terms and conditions as exist prior to transition.

Approximately 30 per cent of all community lab tests are currently provided by private-sector partners, including 73 per cent in the Edmonton and North zones.

"Laboratory testing is critical to the diagnosis and management of patient health that requires highly trained technical staff and medical experts. Our staff have played a critical role in Alberta's response to COVID-19, and their expertise will be important in ensuring the quality and consistency of lab service is maintained across the province," said Mauro Chies, Board Chair of APL, and Vice President of Cancer Care Alberta and Clinical Support Services.

In order to ensure that small rural and remote communities continue to receive the service they need, hospital sites that currently handle less than 25,000 community blood test collections per

year will continue to do so by APL. Larger communities will expect to be serviced by the private provider(s) through community collection sites.

AHS and APL have secured a third-party sourcing facilitator to lead the procurement process, as well as provide advice, strategic planning and project facilitation. The evaluation of proposals will include a detailed analysis by a panel that includes medical/scientific experts, laboratory operations professionals and financial analysts.

A contract is expected to be awarded in spring 2021, with full transition of community lab work transitioned to the successful proponent(s) in 2022.

Good morning,

As mentioned in our meeting last week, we would like to request that all municipalities encourage their residents to download the secure ABTraceTogether app. Unlike the federal app, ABTraceTogether is directly integrated with

Alberta's contact tracing system. Notification of exposure is left to health experts to follow up directly with those at risk, support them in their recovery and ensure they isolate. In the time since ABTraceTogether launched, we have made a number of improvements. We updated the app in September to address any privacy concerns and allow it to run in the background on IOS. It can detect interactions between two iPhones while the app is in the background or on a locked iPhone.

The technology in ABTraceTogether has been successfully used in Singapore, Australia and other places to stop the spread of COVID19. And while any app is only one small part of the fight against COVID19, ABTraceTogether remains an effective public health tool.

Council Meetings

Can municipal councils still meet in person and meet the Chief Medical Officer of Health's recommendations for physical/social distancing?

YES. The Public Meeting Procedures (COVID-19 Suppression) Regulation enables municipalities to follow the Chief Medical Officer of Health's recommendations for physical/social distancing by conducting meetings electronically. While Municipal Affairs encourages councils to consider electronic meetings as a way to ensure compliance with the public health orders regarding public gatherings, the decision on how to conduct meetings remains at the discretion of the council, committee or commission.

Can meetings be held entirely by electronic means?

YES. During the COVID-19 health emergency, when the *MGA* requires a council, board or commission to hold a meeting, an electronic meeting (e.g., livestream, teleconference, etc.) meets that requirement as long as:

- notice of the electronic meeting is provided and states the electronic means being used and gives the information necessary for the public to access the meeting;
- the public is able to hear the meeting as it is occurring;
- eligible parties can send submissions before and during the meeting by email or any other method that the council, board or commission considers appropriate; and

- the following people attend by electronic means:
 - CAO or designated officer;
 - For a commission, growth management board or subdivision and development appeal board, the chair or vice-chair;
 - For a composite or a local assessment review board, the presiding officer.

Can a member of the public be required to wear a mask in order to attend a council meeting?

Masks are only mandatory for municipalities included in the "enhanced areas" or in any other municipalities excluded from "enhanced areas" if there is a municipal face covering bylaw that requires masks to be worn within public buildings.

Enhanced Restrictions

What restrictions on activities apply for all of Alberta?

Throughout all of Alberta, no indoor social gatherings are permitted, and outdoor social gatherings are restricted to 10 people. Wedding and funeral services are restricted to 10 people, and no receptions are permitted. Festivals and other events are prohibited, and working from home arrangements should be considered whenever possible.

What additional restrictions apply only to municipalities that fall within an "enhanced" status area?

Places of worship are restricted to a maximum of 1/3 of attendance capacity, and masks must be worn while inside places of worship.

Banquet halls, conference centres, trade shows, auditoria, concert venues, non-approved/licensed markets, community centres, children's play places or indoor playgrounds, and all levels of sport must be closed (exemptions may be considered for sport activities). This would mean that council meetings cannot be relocated into local banquet halls.

Museums, galleries, libraries, indoor entertainment centres and indoor fitness facilities are restricted to 25% of the occupancy set by the Alberta Fire Code. Further information on business restrictions can be found on Alberta.ca.

What municipalities do the mandatory masking requirements apply to?

Mandatory masking applies in the following communities:

- Calgary, Airdrie, Chestermere, Cochrane, Foothills County, High River, Okotoks, Rockyview County, and surrounding villages and businesses
- Edmonton, Beaumont, Devon, Evansburg, Fort Saskatchewan, Gibbons, Leduc, Leduc County, Morinville, Parkland County, St. Albert, Spruce Grove, Stony Plain, Strathcona County, Sturgeon County, Thorsby, and surrounding villages and businesses

Enforcement of Health Orders

Is the province working on standardizing what is subject to penalties to ensure there is clarity and consistency between enforcement bodies for enforcement under the *Public Health Act*?

YES. Alberta Justice and Solicitor General, in collaboration with Alberta Health and Alberta Health Services, have been in constant contact with Alberta's police services through the Alberta Association of Chiefs of Police, and directly with authorized employers of community peace officers (municipalities) regarding enforcement of Alberta's Chief Medical Officer of Health's orders to ensure a clear and constant message around the enforcement of these orders is being provided.

Can community peace officers enforce the recommendations of the Chief Medical Officer of Health?

YES. Community Peace Officer Level 1s have been provided authority to enforce the Chief Medical Officer of Health's Orders issued under the *Public Health Act*. This authority was granted through a Ministerial Order in accordance with section 13 of the *Peace Officer Act*.

Can municipal bylaw enforcement officers who are not designated as community peace officers enforce the recommendations of the Chief Medical Officer of Health?

NO. Municipal bylaw officers can only enforce municipal bylaws.

General Information

Can municipalities choose to keep certain municipally controlled properties closed even if they are allowed to be open under the provincial approach?

YES. The decision to open facilities remains a local council decision. Municipalities and the public must continue to put safety first while gradually reopening businesses, resuming activities and getting people back to work.

Should municipalities be encouraging employees to work from home?

YES. If there is a concern about exposure to COVID-19, staff should be encouraged and supported in remote work arrangements where possible and feasible.

Can a municipality declare a pandemic State of Local Emergency (SOLE), create local enforceable restrictions and provide for the staged opening of businesses and facilities?

YES. If a municipality determines that an emergency exists in the municipal boundaries that requires coordination or action to protect the safety, health and welfare of people, a pandemic SOLE can be declared and municipalities can then restrict travel into, out of, and within the municipality, and close municipal properties. They can also make plans for repurposing public and private facilities such as community centres or hotels to house people with COVID-19 symptoms to self-isolate. The Emergency Management Act does not include powers to close a business, or reduce the capacity of businesses operating in the municipality.

Can a municipality maintain physical gathering restrictions by declaring a local pandemic SOLE under the recent amendments to the *Emergency Management Act (EMA)*?

NO. If a municipality determines that an emergency exists in their boundaries that requires action to protect the safety, health and welfare of people, a SOLE can be declared; however, municipal powers are specifically identified in the *EMA* and restrictions on gatherings and social distancing are not included within those municipal powers

Frequently Asked Questions - December 4, 2020

On November 24, 2020, the Government of Alberta declared a State of Public Health Emergency and announced several new mandatory public health measures to protect the health system and slow the spread of COVID-19, based on recommendations from the Chief Medical Officer of Health. These measures can be reviewed on Alberta.ca.

While all levels of government continue to navigate the ever-evolving COVID-19 pandemic together to bend the curve, Municipal Affairs remains committed to issuing regular updates to address frequently asked questions as well as provide new information or resources as they become available. Enhanced Status

Is the Provincial Relaunch Status Map revisited so municipalities can be moved on and off the enhanced status list as cases in the area increase or decrease?

YES. Communities can enter the enhanced category while the measures are in place and then must adhere to the more stringent public health measures to protect the health system and reduce the rising number of COVID-19 cases. Communities that are on the enhanced status list at any time on or after November 27 must keep all measures in effect until at least December 15. Municipalities should continue to monitor the status of their region online and can sign up to be notified if their region moves up to 'watch' or 'enhanced' status.

Council Meetings

Can councils in both areas with high case counts (Enhanced Areas) and in areas with lower cases (Open Areas) continue meeting in public?

YES. All councils may continue to meet in public if they can adhere to social distancing guidelines and ensure measures are in place to prevent the transmission of COVID-19. The Public Meeting Procedures (COVID-19 Suppression) Regulation also remains in effect and enables municipalities to conduct meetings electronically. While electronic meetings are encouraged as a way to ensure compliance with the public health orders regarding public gatherings, the decision on how to conduct meetings remains at the discretion of the council, committee or commission.

Can councils located outside enhanced areas hold their meetings in a community centre?

YES. To clarify information provided December 1, 2020 from Alberta Health Operations, councils outside of enhanced areas can still hold meetings in centres if they can adhere to social distancing guidelines. Holding council meetings in community centres within enhanced areas remains restricted at this time.

Can the public be required to wear masks in order to attend a council meeting?

YES. Masks are only required to be worn for indoor public meetings in areas specified in Part 4 of CMOH Order 38-2020 or in any other municipality that has a municipal face covering bylaw that requires masks to be worn in public buildings. For communities specified in Order 38-2020, masks should be worn at all times during a council meeting. Where councils have elected to make masks mandatory in public spaces, the requirements are at the discretion of council and should be outlined in each individual municipal face covering bylaw.

Can a face covering bylaw be passed so that it comes into effect upon a condition, instead of the date of passage?

YES. A bylaw comes into effect on the day it receives third and final reading and is signed by the chief elected official and a designated officer. A bylaw may specify a future date for the bylaw to come into effect, but it cannot apply retroactively. A bylaw may contain provisions that can "trigger" the bylaw's effective date, such as a specified number of COVID-19 cases within the municipality or the region being put into enhanced status. However, a bylaw cannot contain provisions allowing council to enact or repeal the bylaw by resolution, as this is contrary to section 191(2) of the *Municipal Government Act* (MGA).

Alberta Biz Connect

Alberta Biz Connect provides workplace guidance and support to businesses and non-profits. The online tool also provides sector-specific guidelines to ensure businesses can reopen safely during the COVID-19 pandemic. Travel Restrictions

Are there restrictions in place to prevent residents of communities in enhanced areas from travelling into other regions to use their municipal facilities?

NO. Travel within or outside of Alberta is not restricted at this time; however, non-essential travel is not recommended. The Chief Medical Officer of Health encourages municipalities to take measures to limit access to municipal facilities by teams and groups from outside their areas.

Elections

With the restrictions for areas with enhanced measures and the 2021 election nomination period beginning January 1, 2021, are candidates able to submit their nominations while still adhering to the social distancing requirements?

YES. Section 28 of the Local Authorities Election Act (LAEA) states that "nominations shall be submitted at the local jurisdiction office at any time during the nomination period". Ultimately, it is the responsibility of the candidate to ensure their nomination requirements are complete in all aspects, including the inclusion of a deposit if a municipality has a bylaw requiring deposits. In addition to being delivered in person, the specific requirement of section 28 to submit nomination forms can be met by having forms mailed or delivered by courier. This could pose a risk for delivery quarantee that the candidate should be aware of as it is the responsibility of the candidate to meet the requirements of the LAEA and have information submitted to the local jurisdiction office by the deadline on nomination day.

Municipal Operations

Can our municipal administrative offices and other public buildings where we provide public and essential services remain open?

YES. Unless they are explicitly listed in Appendix A of Order 39, there are no restrictions in place. Municipalities must follow the Guidance for Office Buildings and General Relaunch Guidance. Within the enhanced areas, workers must wear a mask unless working alone in an office or an appropriate barrier is in place. Closing municipal offices and public buildings to protect the health and welfare of employees and the public, or for staffing and financial reasons remains at the discretion of individual municipalities.

Many municipal facilities have recreation centres, fitness centres, libraries and meeting space all under one roof. Do the stronger health measures impact capacity in these multi-use facilities?

YES. In buildings (e.g., rec centres) that house multiple uses, the municipality must ensure a process to limit total occupancy to 25 per cent of the fire code limit for that location and ensure the number of attendees does not exceed this number. Individual venues within the larger facility must also follow the applicable restrictions. These guidelines also apply to local businesses operating within larger buildings such as business centres and malls. In communities under an enhanced status, some businesses will be restricted to appointment only and must follow all public health guidance in place. Individual operators should review Order 39, Appendix A, and the overview of enhanced restrictions to determine the operating restrictions for each venue.

Is there guidance documentation available for municipalities and local businesses regarding reduced capacity and occupancy loads, as well as approximating restricted capacity? YES. Information has been posted <u>online</u>, including additional information on how to approximate restricted capacity if municipalities are unsure of current occupant loads, or have been unable to locate them.

Are municipal outdoor rinks permitted to remain open at this time?

YES. Skating is permitted with members from individual households if physical distancing is maintained at all times. If a group of people attend a rink together to skate, this is a social gathering, therefore, groups cannot be more than ten people unless from the same household. Games like shinny or pick up hockey should not occur.

Are there any uses for which community centres in enhanced areas can remain open?

YES. Community centres in enhanced areas can remain open to the public if they are being used to provide health care services or child care services, shelter vulnerable persons, for election purposes and related activities, to undertake jury selections, for indoor markets, or as a place of worship.

On December 8, 2020, the Government of Alberta announced additional public health orders to protect the health system and slow the spread of COVID-19, based on recommendations from the Chief Medical Officer of Health. Active public health orders can be reviewed on Alberta.ca.

The new measures announced on December 8 apply province-wide and will be in place until at least January 12, 2021. Restrictions on businesses and facilities come into effect December 13, at 12:01 am.

Mandatory Masks

Is the use of masks mandatory province-wide now?

YES. Mask use is now mandatory across the province (with some exceptions for farming or ranching operations when not interacting with the public, as well as for certain individuals and activities).

Provincial Relaunch Status Map

The <u>Provincial Relaunch Status Map</u> has been updated to move every region in the province to the purple 'Enhanced Status'. Are the orders put in place on November 27 now in effect for all areas?

NO. Order 39 only applies to communities that previously met the case rate thresholds (active case rate of 50 cases per 100,000 people, and a minimum of 10 active cases) and were listed as "Enhanced Status".

Should your area reach the case rate threshold prior to Sunday, December 13, 2020, then the measures found in <u>Order 39</u> will become applicable.

Municipalities should monitor active cases and active case rates that are found on the relaunch map, which updates around 4:00 p.m. daily. Prior to Sunday, December 13, Alberta Health will provide a notification email to municipalities where cases trigger the Order 39 measures.

Public Meetings

Can municipal councils still meet in person within council chambers?

YES. Business meetings remain excluded from social gatherings so municipal councils may continue to meet in public if they can adhere to social distancing guidelines and ensure measures are in place to prevent the transmission of COVID-19.

The new orders prohibit the use of community centres for council meetings in all areas within Alberta. Are there alternatives available if our municipality cannot adhere to social distancing guidelines?

YES. The Public Meeting Procedures (COVID-19 Suppression) Regulation remains in effect until it has been repealed. The regulation enables municipalities to follow the Chief Medical Officer of Health's orders for physical/social distancing by conducting meetings electronically.

While Municipal Affairs encourages councils to consider electronic meetings as a way to ensure compliance with the public health orders regarding public gatherings, the decision on how to conduct meetings remains at the discretion of the council, committee or commission, while ensuring the process used complies with current public health orders.

Can our municipality still proceed with an inperson public hearing at a community centre if the meetings was scheduled before the restrictions came into place?

NO. All community halls must remain closed to the public unless the hall is being used for a permitted use including providing health care services, child care services, shelter for vulnerable persons or being used for elections purposes and related activities, to undertake jury selections, as a place of worship or indoor market.

Our municipality can no longer hold a property tax recovery public auction given the new province-wide restrictions on community centres. Can we adjourn the auction until these restrictions have been lifted?

YES. Section 422 of the MGA authorizes municipalities to adjourn an advertised public auction for up to two months if it cannot be conducted in accordance with the current public health orders. If there are legitimate reasons to postpone a public auction past the two-month adjournment period, a municipality can request a Ministerial Order from the Minister of Municipal Affairs to extend the period of time in which an auction may be adjourned. This request can be made by sending an email or a letter from the CAO to ma.lgsmail@gov.ab.ca stating the request and the reason(s) and a proposed date for the extension.

Municipal Operations

Is our municipality expected to follow the same four-week mandatory work at home rule?

YES. The new orders include a mandatory province wide work from home requirement where operationally possible, effective December 13. Municipalities should support staff work from home arrangements unless their role requires a physical presence for operational effectiveness.

Are we able to have a small number of staff remain in the office to accept nomination papers, utility payments, etc.?

YES. It is up to each municipality to determine what is operationally required and put in place measures that adhere to the active public health orders and protect the health and safety of the public and employees that are deemed critical to operational effectiveness.

Elections

Is there a contingency plan for the 2021 municipal elections if the pandemic is still ongoing?

YES. Municipal Affairs has met with key municipal stakeholders to discuss potential risks relating to the 2021 municipal general election, and have identified a number of temporary modifications that could be made, if needed, to specific requirements under the Local Authorities Elections Act (LAEA). These modifications, if needed, will provide municipalities with additional flexibility and greater ability to align election operations with public health orders or recommendations.

As the 2021 election nomination period begins January 1, 2021, are candidates able to submit their nominations while still adhering to the social distancing requirements?

YES. Section 28 of the LAEA states that "nominations shall be submitted at the local jurisdiction office at any time during the nomination period". Ultimately, it is the responsibility of the candidate to ensure their nomination requirements are complete in all aspects, including the inclusion of a deposit, if a municipality has a bylaw requiring deposits.

In addition to being delivered in person, the specific requirement of section 28 to submit nomination forms to the local jurisdiction office can be met by having forms mailed or delivered by courier. However, this could pose a risk for candidates if the information is not submitted to the local jurisdiction office by the deadline on nomination day.



We have candidates that are eager to start incurring campaign expenses and raise funds so they want to submit nomination forms as soon as possible in January. Given that candidates can mail or send by courier, and the forms must be signed by a returning officer, are there alternative options available if the returning officer is unavailable or working from home?

YES. The order states employees should work from home "where operationally feasible", so nomination forms can be accepted at specific times set by the returning officer, by appointment, or at a secure drop box. Municipalities have the authority to determine options that safely enable the submission of nomination forms.

Travel Restrictions

Are there any new restrictions on travel within or outside the province at this time?

NO. Travel within or outside of Alberta remains unrestricted at this time; however, non-essential travel is not recommended. The Chief Medical Officer of Health encourages municipalities to take measures to limit access to municipal facilities by teams and groups from outside their areas.

Dear Chief Elected Official,

On July 30, 2020, our government was proud to announce the Municipal Stimulus Program (MSP). One of the conditions associated with this funding is that municipalities are required to reduce red tape, and this email provides further information about what this commitment entails.

Municipalities are required to take actions that advance at least one of the following objectives:

- Make it easier to start up a new business in your community.
- Streamline processes and shorten timelines for development and subdivision permit approvals.
- Make your community a more attractive destination for new investment and/or tourism.

The attached report templates provide some examples of actions you could take to achieve these objectives, but you are not limited to these examples. Each municipality must determine the most appropriate actions for their local circumstances. I strongly encourage you to think carefully about what actions would result in the most benefit for your local economy, and pursue those actions diligently. If you are unsure which actions will be most effective, I urge you to speak with local job creators in your area to understand how you can best support them.

There are separate report templates for 2020 and 2021.

- Municipalities must submit the 2020 report template to ma.municipalstimulus@gov.ab.ca before February 1, 2021, indicating any actions they have undertaken in 2020 to reduce red tape and how they intend to reduce red tape in 2021.

EXECUTIVE SUMMARY

Overview

Introduction

Municipalities prepare assessments in accordance with Part 9 of the *Municipal Government Act* (MGA) and the regulations. Assessment audits are performed under the authority of section 22 of the *Matters Relating to Assessment and Taxation Regulation, (203/2017)* by assessment auditors appointed by the Minister of Municipal Affairs. The *Detailed Assessment Audit Manual* guides the auditors' work. This report is intended to be read in conjunction with the *Detailed Assessment Audit Manual*. The manual is meant to be used by auditors to facilitate a consistent approach to detail audits, or can be used by municipalities as a tool for self-review.

Objective of the Audit

The objective of this detailed assessment audit is to provide an unbiased opinion as to the quality of the municipality's assessment roll for the 2020 tax year. The opinion is based on a review of assessment performance by measuring the degree to which assessments meet regulated quality standards and a review of procedures and administration of the municipality's assessment program. The audit also provides a means to identify and reinforce strengths in a municipality's assessment program and to identify where opportunities exist to improve assessments or assessment administration.

The audit meets this objective by providing brief findings and conclusions for individual tasks meeting best practice guidelines and/or legislative requirements as outlined in the *Detailed Assessment Audit Manual.* For tasks not meeting legislative or best practise requirements and requiring a recommendation, the auditor provides more detail and explanation of findings supporting conclusions.

Scope of the Audit

This detailed assessment audit will review assessment performance for those properties for which the municipality is legislatively required to prepare assessments, as well as an administrative review. Ratio studies serve as the primary tool for the objective evaluation and measurement of mass appraisal performance. The procedural review will focus on how assessments are prepared and will involve a pool of sample properties for testing.

The following topics are out of scope for this audit:

Provincial and municipal tax policy.





Findings of Audit

In our opinion, the Village of Alberta Beach, in preparing its assessment roll for the 2020 tax year, meets virtually all of legislated standards. Most aspects of procedures and practices used in preparation of property assessments meet assessment best practices.

In addition, an administrative review of the municipality's management of the assessment program finds legislative requirements have been met for the administration of bylaws, assessment rolls, notices, complaints and public relations.

Recommendations:

Compliance with Legislation Requirements

No recommendations are offered.

Best Practice Recommendations

 It is recommended that the assessor use a consistent valuation approach in assessing non-residential properties.

Observations

 It is advisable for the municipality to develop a formal MGA section 299/300 request form and process to ensure appropriate handling of a formal request.

PERFORMANCE REVIEW

A performance based review provides direct evidence of valuation accuracy and uniformity of properties assessed at market value.

Sold Parcel Reconciliation

Using Land Titles Office data, Assessment Audit reviews whether the assessor is reporting the appropriate number of sales to ASSET. A review is also conducted to identify if the assessor is including all *good* sales as valid for statistical review.

Sales Verification

Assessors are expected to screen land titles transactions and assign sales verification codes indicating whether the sale is representative of market value and can be used in market analysis and ratio studies, or whether the sale is not representative and is invalid.

The following table is a summary of sales verification coding as submitted by the assessor into Assessment Shared Service Environment (ASSET) system for the 3-year period July 1, 2016 to June 30, 2019.

The auditor reviewed a sample of registration documents of included and excluded sales. For the most part, sales verification codes are found to be applied appropriately. Sales that are coded as Good Sale but excluded in the analysis are sales with outlier ratios.

The assessor appears to be using discretion appropriately. Therefore, auditor ratio studies will use the assessor's reported sale set.



Time Adjustments

The Matters Relating to Assessment and Taxation Regulation (MRAT) states that any assessment prepared in accordance with the MGA must be an estimate of value on July 1st of the assessment year. The most common sale price adjustment that the assessor will make is for price since the time of sale.

The most common method of determining time adjustment is sales-assessment ratio trend analysis (SAR). The auditor used this method in testing the time adjustment factors applied by the assessor. This was done on single family (SFD). Other property groups do not have enough sales in order to arrive at a reliable conclusion.

Of note, the results of the auditor's time adjustment analysis is very close to that of the assessor's. These are illustrated in the following graph and table:

Conclusion

The time adjustment factors developed by the assessor for the SFD group, which has sufficient sales for analysis, are in line with the factors resulting from the auditor's time adjustment analysis. Differences, if present, are minimal. The proceeding ratio study will use the assessor's time adjustment factors.

Other Sale Price Adjustments

Occassionally, other adjustments are employed (chattels for example). For SFD in particular, these types of adjustments should rarely be used. The assessor has not applied any other adjustments to sale prices in the submission to ASSET.

Ratio Studies

Market value assessments must meet median assessment ratio and coefficient of dispersion standards. Performance-based review (ratio studies) provide direct evidence of valuation accuracy and uniformity of properties assessed at market value. Ratio studies are an essential tool for objective evaluation and measurement of mass appraisal performance.

Various statistical studies were undertaken to review quality and uniformity of assessments within the assessment roll. Conclusions are made when a sample size is 15 or more of sold properties within a particular stratum for the preceding three years. If the sample is less than 15 but more than five; and, if the sales are judged to be representative of the population, some weight may be accorded to results. The *Matters Relating to Assessment and Taxation Regulation* sets forth requirements for assessment quality and uniformity. Statistical testing measures whether standards are met. For any stratum, median assessment ratio and corresponding coefficient of dispersions (COD) must be within the following ranges:



SFD Properties by Age:




The trendline from ASR vs. Year Built indicates the median assessment ratio is virtually identical across the age band; a desirable result.

SFD Properties by Floor Area:




This trendline shows properties with differing building size are assessed at a consistent level.

SFD Properties by Parcel Size:




The nearly flat trendline indicates assessment levels are consistent across property size.

VALUATION OF SIMILAR PROPERTY

Uniform and equitable assessments:

SOLD VS: UNSOLD ANALYSIS

The objective of ratio studies is to determine appraisal performance for the population of properties; that is, both *sold* and *unsold* parcels. If sold parcels are selectively reassessed based on their sale prices, assessment values in ratio studies are not representative of the total population and may distort ratio study results.

Findings:

Assessment Audit reviewed the *sold* sample, and the *unsold* population to determine if their change (or shift) in assessment from the previous year is similar. A substantially greater year-over-year change in assessment of *sold* properties, when compared to *unsold* properties, could be an indication of selective re-assessment. For audit purposes, if there are differences of greater than 5% between *sold* and *unsold* properties, they are flagged for review. The results are as follows.


The indicated difference between sold and unsold properties is 0.28%; well within tolerance.


As a whole, based on preceding statistical tests and property viewing, the SFD group meets with best practices.

Vacant Land

There are almost no sales for the assessor to review for vacant land. The chart below shows the land size vs. the assessment values; it shows that assessed value increase as the parcel size increases.



A typical land assessment model would reflect the principle of *diminishing returns*, where larger lots are worth more, but at a declining unit (sq.ft.) rate. This is confirmed by the chart below.



Based on the foregoing, VR assessments appear to be reasonable.

Recommendations:

No recommendations are offered.

Residential Property

Residential property includes single family (SFD), multi-family (MF), and vacant residential (VR).

For these property types, there are two valuation methods used; the sales comparison, and market-modified cost approaches. Sales comparison requires a sufficient mass of similar sales to invoke unit rates for modelling purposes, and is rarely used in small municipalities.

The assessor reasonably chooses the market-modified cost approach for improved residential. The biggest steps within the cost approach are land valuation, estimating replacement cost new, deducting depreciation, and reconciling (modifying) to limited sales data.

The audit process relies heavily on property viewing. Direct, property-specific observation can reveal subtleties not apparent in a strict statistical analysis (preceding sections). The auditor viewed, by exterior observation, a sample of improved properties. The process considers application of the cost approach to *sold* v. *unsold* properties, various architectural styles, ages, locations, qualities, and lot sizes. The review process checks if application of cost new, market modifiers, quality ratings, depreciation, and land value are consistent with similar properties. The review also checks the inventory of structures (dwellings, garages, sizes, carports, decks, fireplaces, etc.).

No material discrepancies between observation and assessment record were identified. Direct observation confirms the assessment record reflects changes in property data (building permits, additions/deletions); and assessments of *sold* properties align reasonably with sale prices.

SFD CONCLUSION:

Ratio study results for Single Family Dwellings (SFD) are within quality standards. Upon direct viewing sale prices v. assessments are reasonable.

Non-Residential (NR)

Non-residential includes Industrial (IND), Retail (RET), Office (OFF), and Special Purpose (SPEC).

Any of the three approaches to value might have applications for non-residential property. The three valuation approaches are; sales comparison, income, and cost. Sales comparison requires a sufficient mass of similar sales to invoke unit rates for modelling purposes. The market approach is rarely used for non-residential in small municipalities; similar to SFD.

The income approach is based on the premise property values are expressed as a priceearnings multiple of typical rent. A sufficient number of rent rates from the area are required for the income approach to be valid.

For the most part, the assessor used the cost approach (Marshall & Swift) in assessing non-residential properties within Alberta Beach. However, there are few properties that were assessed using the income approach. Of the twenty-three retail properties, four were assessed on income approach. For the three hotels, only one is assessed using income approach.

The few commercial properties within the Village are a mixture of owner occupied and leased properties. Assessment best practice prescribe to use the income approach in the valuation of income producing properties, provided that sufficient income information is available. The assessor indicated that to use the income approach, he is using income rates from other jurisdictions, due to insufficient actual income information available in Alberta Beach. This is a reasonable practice provided in depth analysis is needed to make sure that the rates used are from the same property or space types.

For the purpose of consistency, it is recommended that the assessor reviews the valuation approaches being used for non-residential properties and determine the appropriate valuation approach.

Non-Residential Recommendations

It is recommended that the assessor use a consistent valuation approach in assessing non-residential properties.

The table above shows that practically 100% of properties have experiences some form of inspections in the last five years. An excellent result.

Property Characteristics at Date of Sale

Findings and Conclusions:

Property characteristics at sale date may be different from characteristics as of December 31 in a subsequent assessment year (condition date). According to IAAO texts and the *Property* Assessment in Alberta Handbook, assessors should preserve a "snapshot" of property details at sale date so prices and property characteristics match, and ratio studies not distorted.

The assessor's computer assisted mass appraisal (CAMA) system tracks changes to improvements since any sale.

Special Purpose Property

A special purpose property is typically a large, distinct-in-nature, industrial property constructed to transform raw materials into product. Special purpose properties could include facilities such as public utility buildings, refineries, power plants, natural gas plants, mills, and grain handling facilities. Location is a key factor for industrial plants; they are generally located near the source of raw materials or within reasonable distance to a major transportation network.

Alberta Beach has just three parcels marginally qualifying under the Special Purpose designation. These two were included in our cost approach detail review along with other nonresidential property. The valuation details are in keeping with the property type, and are consistent with the balance of non-residential assessments.

At the City of Cold Lake's regular Council meeting, held on November 24, 2020, City Council debated concerns being raised by our residents relating to access to the Government of Canada's "COVID-19 Alert" mobile application.

In the Cold Lake context, these concerns are exacerbated due to our proximity to the Province of Saskatchewan, the City of Cold Lake's position as an economic hub in the northeast, and the presence of CFB Cold Lake. Many Saskatchewan residents are using the federal COVID-19 contact/exposure alert application and come to our community to shop and access healthcare services. It is our hope that a solution may be found that would allow the Government of Alberta to enable the federal government's application, or to harmonize the Alberta tracing application with the federal one.

We understand that the "ABTraceTogether" was launched in May 2020 and the Government of Canada developed its "COVID-19 Alert" at a later date, and that this has caused concerns relating to provincial coordination and potential confusion between different applications.

Our Council feels that the Government of Alberta deserves much credit in its quick response, development, and deployment of its tracing application. Since inter-provincial travel and trade is critical to our economy and will be a large factor in our post COVID recovery, however, it is our hope that a Canada-wide solution can be implemented as soon as reasonably possible.

Although the federal government's application may have been late, it has the unique advantage of being able to trace contacts across the country. Our residents feel there are significant benefits a Canada-wide approach can bring to help safely strengthen interprovincial travel and trade.

In response to our residents' concerns, Council passed the following resolution:

Moved by Councillor Vining that Council consider a letter to the Government of Alberta urging it to open access to the federal COVID-19 mobile app in Alberta.

WHEREAS Canada is in the midst of a global pandemic relating to the COVID-19 virus, during which health experts have expressed the need to be able to trace people who may have been exposed to the virus in an effort to break the cycle of infection; and

Frequently Asked Questions - December 11, 2020

On December 8, 2020, the Government of Alberta announced additional public health orders to protect the health system and slow the spread of COVID-19, based on recommendations from the Chief Medical Officer of Health. Active public health orders can be reviewed on Alberta.ca.

The new measures announced on December 8 apply province-wide and will be in place until at least January 12, 2021. Restrictions on businesses and facilities come into effect December 13, at 12:01 am.

Municipal Affairs remains committed to issuing regular updates to address frequently asked questions as well as provide new information or resources as they become available. If you would like a specific issue addressed in an upcoming update, please email your request to ma.lgsmail@gov.ab.ca.

Mandatory Masks

Is the use of masks mandatory province-wide now?

YES. Mask use is now mandatory across the province (with some exceptions for farming or ranching operations when not interacting with the public, as well as for certain individuals and activities).

Provincial Relaunch Status Map

The <u>Provincial Relaunch Status Map</u> has been updated to move every region in the province to the purple 'Enhanced Status'. Are the orders put in place on November 27 now in effect for all areas?

NO. Order 39 only applies to communities that previously met the case rate thresholds (active case rate of 50 cases per 100,000 people, and a minimum of 10 active cases) and were listed as "Enhanced Status"

Should your area reach the case rate threshold prior to Sunday, December 13, 2020, then the measures found in Order 39 will become applicable.

Municipalities should monitor active cases and active case rates that are found on the relaunch map, which updates around 4:00 p.m. daily. Prior to Sunday, December 13, Alberta Health will provide a notification email to municipalities where cases trigger the Order 39 measures.

Public Meetings

Can municipal councils still meet in person within council chambers?

YES. Business meetings remain excluded from social gatherings so municipal councils may continue to meet in public if they can adhere to social distancing guidelines and ensure measures are in place to prevent the transmission of COVID-19.

The new orders prohibit the use of community centres for council meetings in all areas within Alberta. Are there alternatives available if our municipality cannot adhere to social distancing guidelines?

YES. The Public Meeting Procedures (COVID-19 Suppression) Regulation remains in effect until it has been repealed. The regulation enables municipalities to follow the Chief Medical Officer of Health's orders for physical/social distancing by conducting meetings electronically.

While Municipal Affairs encourages councils to consider electronic meetings as a way to ensure compliance with the public health orders regarding public gatherings, the decision on how to conduct meetings remains at the discretion of the council, committee or commission, while ensuring the process used complies with current public health orders.

Can our municipality still proceed with an inperson public hearing at a community centre if the meetings was scheduled before the restrictions came into place?

NO. All community halls must remain closed to the public unless the hall is being used for a permitted use including providing health care services, child care services, shelter for vulnerable persons or being used for elections purposes and related activities, to undertake jury selections, as a place of worship or indoor market.

Our municipality can no longer hold a property tax recovery public auction given the new province-wide restrictions on community centres. Can we adjourn the auction until these restrictions have been lifted?

YES. Section 422 of the MGA authorizes municipalities to adjourn an advertised public auction for up to two months if it cannot be conducted in accordance with the current public health orders. If there are legitimate reasons to postpone a public auction past the two-month adjournment period, a municipality can request a Ministerial Order from the Minister of Municipal Affairs to extend the period of time in which an auction may be adjourned. This request can be made by sending an email or a letter from the CAO to ma.lgsmail@gov.ab.ca stating the request and the reason(s) and a proposed date for the extension.

Municipal Operations

is our municipality expected to follow the same four-week mandatory work at home rule?

YES. The new orders include a mandatory province wide work from home requirement where operationally possible, effective December 13. Municipalities should support staff work from home arrangements unless their role requires a physical presence for operational effectiveness.

Are we able to have a small number of staff remain in the office to accept nomination papers, utility payments, etc.?

YES. It is up to each municipality to determine what is operationally required and put in place measures that adhere to the active public health orders and protect the health and safety of the public and employees that are deemed critical to operational effectiveness.

Alberta

Elections

Is there a contingency plan for the 2021 municipal elections if the pandemic is still ongoing?

YES. Municipal Affairs has met with key municipal stakeholders to discuss potential risks relating to the 2021 municipal general election, and have identified a number of temporary modifications that could be made, if needed, to specific requirements under the Local Authorities Elections Act (LAEA). These modifications, if needed, will provide municipalities with additional flexibility and greater ability to align election operations with public health orders or recommendations.

As the 2021 election nomination period begins January 1, 2021, are candidates able to submit their nominations while still adhering to the social distancing requirements?

YES. Section 28 of the *LAEA* states that "nominations shall be submitted at the local jurisdiction office at any time during the nomination period". Ultimately, it is the responsibility of the candidate to ensure their nomination requirements are complete in all aspects, including the inclusion of a deposit, if a municipality has a bylaw requiring deposits.

In addition to being delivered in person, the specific requirement of section 28 to submit nomination forms to the local jurisdiction office can be met by having forms mailed or delivered by courier. However, this could pose a risk for candidates if the information is not submitted to the local jurisdiction office by the deadline on nomination day.



We have candidates that are eager to start incurring campaign expenses and raise funds so they want to submit nomination forms as soon as possible in January. Given that candidates can mail or send by courier, and the forms must be signed by a returning officer, are there alternative options available if the returning officer is unavailable or working from home?

YES. The order states employees should work from home "where operationally feasible", so nomination forms can be accepted at specific times set by the returning officer, by appointment, or at a secure drop box. Municipalities have the authority to determine options that safely enable the submission of nomination forms.

Travel Restrictions

Are there any new restrictions on travel within or outside the province at this time?

NO. Travel within or outside of Alberta remains unrestricted at this time; however, non-essential travel is not recommended. The Chief Medical Officer of Health encourages municipalities to take measures to limit access to municipal facilities by teams and groups from outside their areas.
